## Report of the Strategic Director of Performance and Development

Recommendation	

The Committee decided to explore the levels of compliance with National Minimum Standards by care homes for older people in Warwickshire following the publication of a number of national reports. In recent months the Commission for Social Care Inspection has been reviewing its inspection arrangements for care homes.

The Committee also considered it an appropriate time to consider the future of residential care in Warwickshire in the light of the White Paper Our Health, Our Care and Our Say.

## OLDER PEOPLE AND RESIDENTIAL CARE

#### **Background**

- Commission for Social Care Inspection (CSCI) national studies indicate generally poor levels of compliance by care homes for older people with significant aspects of the national minimum standards i.e.
  - February 2006 Handle with Care (Medication Standard);
  - ❖ March 2006 Improving Meals for older people in care homes (Nutrition Standard);
  - June 2006 Safe and Sound –checking the suitability of new care staff in regulated social care services
- CSCI is currently consulting on proposals to change the assessment regime –consultation period 1 May to 31 July2006 i.e. Draft Key Lines of Regulatory Assessment (KLORA) Care Homes for Older People
- DOH Review of the National Minimum Standards
- Office of Fair Trading Report into the Care Homes Market (May 2005) found that people need easier access to information when choosing a care home and more support once in a home. Care homes also needed to ensure that fee-related terms in their contracts are fair and transparent.
- A new Vision and Strategy for Adult Social Care is currently under development.
- White Paper Our Health, Our Care, Our Say
- Living Well in Later Life –A review of progress against the National Service Framework for Older People (Audit Commission March 2006)
- National framework for NHS fully funded continuing healthcare and NHS-funded nursing care in England, DOH consultation that runs until 22 September 2006.
