## **Developer Funded Major Roads Schemes**

# Report of the County Treasurer and Director of Planning, Transport and Economic Strategy

#### Recommendations

- (1) That the two capital projects identified in paragraphs 2 and 3 of the report be included in the 2005/2006 capital programme at an estimated cost of £359,000 subject to a Section 278 agreement being signed with the developer.
- (2) That the scheme at High Street, Alcester referred to in paragraph 4 of the report be included in the 2005/2006 capital programme at a cost of £40,000.

#### 1. Introduction

On 18<sup>th</sup> December 2001 Council agreed that in future the Cabinet can approve projects for addition to the capital programme provided that they cost less than £1.5 million and are fully funded from external grants, developer contributions or from revenue. This report deals with three projects costing an additional £399,000, which need to be added to the 2005/2006 capital programme. The projects are:

## 2. Construction of roundabout on Astley Lane, Bedworth

This project involves constructing a small four-arm roundabout to service a residential development at the market end of Astley Lane. The County Council will undertake the works at an estimated cost of £277,500 including fees to be funded by Persimmon Homes under a Section 278 Agreement which is still to be signed. Tenders are due to be received in September 2005 and, subject to Cabinet approval, works will commence in October 2005.

# 3. Access to housing development, minor junction improvement and private parking bay on Poplar Road, Napton-on-the-Hill

It is proposed to construct an access into a residential development and a private parking bay, and to improve a minor junction on Poplar Road, Napton-on-the-hill. The County Council will undertake the works at an estimated cost



of £81,500 including fees to be funded by Manor Park Homes under a Section 278 Agreement which is still to be signed. Tenders are due to be received in October 2005 and, subject to Cabinet approval, works will commence in November 2005.

#### 4. Enhancement works on High Street, Alcester

This project involves enhancement works on High Street, Alcester requested by Stratford District Council. The County Council will undertake the works at an estimated cost of £40,000 including fees to be funded by Stratford District Council. Tenders are due to be received in September 2005 and, subject to Cabinet approval, works will commence in September 2005.
