**Summary** This report confirms the latest position and progress

made in negotiating LPSA2 since Cabinet last considered the matter on 8<sup>th</sup> December 2005. At the time of preparing this draft report we have secured final agreement with central government on 6 Projects (two of which count as 'super targets' and are both worth the value of 2 Projects). Negotiations are at a positive and advanced stage on a further 3 Projects and should be completed by 27<sup>th</sup> January 2006. We met with the lead officer from the Office of the Deputy Prime Minister on 19<sup>th</sup> January 2006 in order to prepare the first draft of the LPSA2 agreement. This, together with a complete report, will be distributed to Cabinet members and others in advance of the

meeting on 2<sup>nd</sup> February 2006.
