Key Stage 4 Results

Report of the Strategic Director for Children, Young People and Families

Recommendation:

That the Committee scrutinise the results of pupils in national tests in Key Stage 4 in Warwickshire schools and support the planned actions proposed to further raise levels of attainment and achievement.

1. Background

- 1.1 At their meeting on 12th November 2007, Members requested that a report outlining the Key Stage 4 results for 2007 be provided to this Committee prior to the Educational Attainment Task and Finish Group commencing its Scrutiny activity.
- 1.2 The performance of Warwickshire pupils is generally higher than the national average on most indicators and in most cases than the average of our statistical neighbours (those authorities considered to be most similar to Warwickshire which therefore provide a better comparator). However performance at Key Stage 4 is less good and Members have asked for a report to this Committee on the results for 2007, and in particular the key indicators:
 - The percentage of pupils gaining 5+ A*-C GCSE grades
 - The percentage of pupils gaining 5+ A*-C GCSE grades including English and maths (the Government's preferred indicator)
 - Average total points score.

2. Warwickshire's performance

- 2.1 Table 1 below shows the Authority's performance compared with the national average, the average of statistical neighbours and the "best in class", i.e. the highest score achieved by any one of our statistical neighbours:

2.2 Table 2 below shows the Authority’s improved performance since 2003 compared with the improvement in national performance:

2.3 Clearly some of these results are disappointing in that they fall below the national figure and are below the LA target. In relation to 5+ A*-C grades at GCSE Warwickshire’s performance is below the national average and progress to improve this performance has been slower than the progress across the country as a whole.

2.4 In relation to the Government’s preferred indicator, 5+ A*-C including English and maths, Warwickshire’s performance is better than the national average and close to the performance of our statistical neighbours. However it is well below the “best in class” level which we have set as our aim.

3. School performance

3.1 **Appendix A** attached shows the 5+ A*-C results including English and maths for individual secondary schools in Warwickshire. **Appendix B** shows the added value (CVA) figures for individual schools. These figures show a concern about achievement in some schools, particularly in Nuneaton and Bedworth, along with a small number of schools in other areas of the county.

3.2 It is important to note that raw scores are a poor indicator of the success of individual schools since they take no account of the prior performance of pupils. The “value added” figures are a better indication of the progress made by pupils in each school. To be able to evaluate these figures in more detail the

results should be compared with the expected levels of attainment and individual school targets.

- 3.3 A presentation giving more detailed analysis of the results will be given to the Committee.

4. Action taken

- 4.1 Clearly improvement in performance can only be achieved by individual schools examining their performance, identifying areas for development and taking action. The Authority's role is, as always, to challenge and support schools in carrying out that exercise of self-evaluation and self-improvement.
- 4.2 School Improvement Partners have visited every school in the autumn term to discuss the 2007 performance and to support the process of self-evaluation. The reasons for underperformance are different from school to school but the Authority is satisfied that headteachers in schools have identified where there are concerns and are acting appropriately to address those concerns.
- 4.3 Short-term action plans are in place to provide, for example, revision and booster classes and support for underperforming departments. Medium-term strategies, for example to improve study skills and pupil's self-esteem and aspirations and to broaden the curriculum offer to ensure its relevance to all young people, are also important. Longer term and more fundamentally the Authority is reviewing the pattern of school provision to ensure that it contributes to raising standards rather than be an obstacle to it.
- 4.4 Further details of the support to schools will be given in the presentation to the Committee.
