- **Power to require Name and Address for Anti Social Behaviour.**
- **Power to require name and address for certain Road Traffic Offences:**

NPIA PCSO Review

July 2008

NPIA lead a tripartite review of PCSO activity which included the Home Office, APA and ACPO

- 22 Recommendations made of which Warwickshire met 21.
- Minor issue with Hat banding was the only recommendation that Warwickshire failed to meet with regards to standardisation of uniform. This is to be resolved early in the new year.

NPIA PCSO Review

July 2008

The review also looked at core roles and principles that should be applied to the role of PCSO.

• **PCSO's should be:**

- **Integrated into a Safer Neighbourhood Team.**
- **Undertake public facing duties in uniform.**
- **Visible in communities on foot or cycle patrol.**
- **Deal with Anti Social behaviour, Low level crime and incidents, local problems/priorities and quality of life issues.**
- **Support and improve service to victims and vulnerable people.**
- **Conduct engagement and problem solving activity.**

All Warwickshire PCSO adopt these core activities and principles



PCSO Funding

- **Home Office funding confirmed up to 2011-2012.**
- **Cost per year equates to £4 million.**
