## **1. General**

The Chair welcomed ACC Andy Parker and Steven Hussey to the meeting.

### **(1) Apologies**

Apologies for absence were received from Councillors Bernard Kirton Barry Longden and Anita Macaulay.

### **(2) Members' Declarations of Personal and Prejudicial Interests**

### **(3) (a) Minutes of the Community Safety Overview and Scrutiny Committee Meeting held on 25 October 2005.**

Resolved –

That the minutes of the Community Safety Overview and Scrutiny Committee's meeting held on 25 October 2005 be approved and signed by the Chair.

**(b) Matters Arising**

Scrutiny Event – Improving Community Safety – Minute 3 Recommendation (4)

The Chair advised Members that he and the Committee spokesperson had agreed the proposed programme for this Scrutiny event. Referring to the discussion at the previous meeting and the follow-up report, item 3 below, he suggested that Members, during discuss of this item might wish to register lines of enquiry that could be addressed at the Scrutiny event.

**2. Public Question Time**

**3. County Council Crime and Disorder Reduction Strategy – Progress Report on four of the seven priorities**

Andrew Lawrence presented the report of the County Solicitor and Assistant Chief Executive, which set out progress on the remaining four of the seven priorities in the County Council Crime and Disorder Reduction Strategy (Young People as Victims and Offenders, Liveability, Alcohol Related Violence and Drug Related Crime).

Viv Sales addressed Members on “Young People as Victims of Crime and Offenders and answered questions on –

- Exclusions and outlined the process (including appeals) and support given;
- Truancy prosecutions and the success rate of penalty notices;

Don Foster and reported on the work being undertaken on “Liveability” (“the aspects of a place which make people happy to live, work and move about there”).

Steve Hussey outlined the work being done to reduce the number of alcohol related incidents of violence leading up to the development of a countywide multi agency alcohol strategy. In particular he reported on the work being undertaken in Rugby.

In reply to questions ACC Andy Parker said that, since the change in the Licensing Laws there had been no increase in crime or violent incidents. The new Law enabled greater control and enforcement of licensed premises.

Kit Leck outlined the work of the Community Safety Partnership and Drug and Alcohol Action Team in reducing the harm caused by drugs.

In reply to questions ACC Andy Parker reported that, in the current year 113 people had been arrested for selling drugs (the target for the year being 150) as compared with 69 arrests the previous year. Those arrested had had goods confiscated with a percentage of the assets being returned to the County.

Councillor Richard Hobbs, in response to Members' concerns about the inconsistency in composition of the Area Crime and Disorder Reduction Partnerships (CDRP), said that he was trying to resolve this issue. The Chair added that there was the need for uniformity across this county in the membership of the CDRPs.

The Committee noted progress on the four priorities detailed in the report and the levels of success achieved so far.

#### **4. Performance Report Half Year 2005/6**

##### **(a) Libraries, Heritage and Trading Standards.**

The Committee, having considered the report of the Director of Libraries, Heritage and Trading Standards, –

(1) noted the performance of Libraries, Heritage & Trading Standards for the half year 2005/06.

(2) Endorsed the proposed remedial action.

##### **(c) Fire and Rescue Service**

The Committee, having considered the report of the County Fire Officer, –

(1) noted the Warwickshire Fire and Rescue Service's performance for the half-year 2005/06.

(2) endorsed the proposed remedial action.

(3) Congratulated the Fire and Rescue Service on its prompt and efficient response the major fire incident that occurred in Hemel Hemstead.

## **(b) Chief Executive's Department**

The Committee considered the report of the County Solicitor and Assistant Chief Executive which provided a half-year update of the achievements of the Chief Executive's Department and partners in meeting the objectives and performance targets set for 2005/06 which related to the Corporate Objective of: To reduce crime and improve the safety of the community'.

In reply to questions ACC Andy Parker said that –

- there had been an increase in violent crime that could be linked to alcohol but there was no quantitative evidence available;
- there had been no increase in robberies or other crime that could be linked to immigrant communities but there had been an increase in people and "sex" trafficking.

The Committee –

- (1) noted the Chief Executive department's performance for the half year 2005/06;
- (2) endorsed the proposed remedial actions.

## **5. 2005/06 Cost Effectiveness Savings – Libraries, Heritage & Trading Standards Progress Report.**

### **(a) Libraries, Heritage and Trading Standards**
