Single Issue meeting: Anti-Social Behaviour in Warwickshire

10.00am 8th February, 2006

1.0 Background

On 25th October, 2005 the Community Safety Overview & Scrutiny Committee received Part 1 of a two part report on the County Council's Crime and Disorder Reduction Strategy. The report concentrated on three of the seven thematic areas addressed by the Strategy:

- Fear of crime
- High crime areas
- Prolific and Priority offenders

The second part of the report was presented to the Committee's meeting of 15th December and concentrated on the remaining four priority areas, namely:

- Alcohol related violence
- Young People as victims and offenders
- Drug related crime
- Liveability

Members of the Community Safety Overview & Scrutiny Committee have also previously received reports on the Departmental Contributions to WCC Crime and Disorder Reduction Strategy (July, 2005) and the Action on Drugs and Alcohol and the Contribution to the Achievement of the Strategic Plan for Warwickshire Targets (September, 2005)

Receipt of these reports has generated strong feeling within the Committee and fueled a debate on the value, appropriateness and effectiveness of the current approaches employed to tackle antisocial behaviour within the communities served by Members of the Committee and in Warwickshire generally.

Committee members recognise that the County Council has a key contribution to make to the work of multi agency partnerships working towards safer communities and further acknowledge the valuable contribution which can potentially be made through the proposed Local Area Agreements Framework.

With this in mind the Community Safety Overview & Scrutiny Committee requested that a full scrutiny exercise be conducted, involving all community safety and criminal justice agencies to provide an opportunity for Members to understand how they can improve Community Safety in Warwickshire by addressing the current levels of anti-social behaviour.

2.0 Objectives

Following the successful delivery of the scrutiny event the Community Safety O&S Committee members will:

- 2.1 Understand what is currently recognised/defined as 'Anti-social behaviour'
- **2.2** Have an understanding of the County Council's remit and role in relation to Anti-Social Behaviour
- **2.3** Understand the contribution of Warwickshire County Council in reducing Anti Social Behaviour and be confident that the proposed actions will deliver real improvement in the level of Community Safety within Warwickshire.
- **2.4** Understand the current infrastructure within Warwickshire for addressing Anti-Social behaviour and the implication of any proposed changes
- **2.5** Have an understanding of current and future the roles and responsibilities of WCC and our partner agencies in working towards increasing Community Safety
- **2.6** Establish what further action needs to be taken to ensure Members of the Community Safety Overview & Scrutiny are confident that Anti Social behaviour is being positively addressed in Warwickshire eg. Further scrutiny review, community consultation etc.
- **2.7** Agree what, if any recommendations should be made to Cabinet

3.0 Expert panel

In previous meetings of the Community Safety O&S Committee Members have highlighted the importance of a partnership approach to delivering Community Safety. In recognition of this the Community Safety Team have liaised with the Police, Criminal Justice agencies and CDRPs to provide an Expert Panel of broad experience and knowledge to which Members can ask questions relating to Anti-Social Behaviour in Warwickshire.

The issues raised by Members at this and previous Community Safety Overview & Scrutiny Committee meetings have been used to develop key lines of enquiry and potential questions for Members to put to the expert Panel.

The questions have been consolidated into broad subject areas and Members will have the opportunity to question the Expert Panel in sessions relating specifically to each of the categories below:

- A balanced approach to ASB (prevention, support and enforcement)
- Crime Statistics
- Neighbourhood solutions
- A Partnership approach
