### Item 7 – Children and Young People’s Plan

Councillor David Booth declared a personal interest as he had a close relative who worked for South Warwickshire PCT supporting families with difficulties.

#### **(3) Minutes**

Resolved:

That the minutes of the meeting held on 11 April 2006 be agreed as a correct record and signed by the Chair.

#### **(4) Police Reform**

Philip Blundell, Chair of the Warwickshire Police Authority, updated the Council on progress of Police Reform but prefaced his report by recording his thanks to John Burbeck, Chief Constable who was retiring from the Police Force. It was noted that Keith Bristow (currently Deputy Chief Constable) would be taking up the post of Chief Constable from 17 July.

Philip Blundell advised that the indication from the Home Office following Cabinet changes was that the programme of police reform would go ahead as planned. A draft model order had been laid in Parliament in February and was due to be confirmed by an amalgamation order within the next 10 days.

A meeting between the authorities and Home Office on 24 April had indicated that two of the main concerns were going to be met, namely that there would be local area committees which would allow local engagement with people and local commanders, and that the request for a higher number of members on the new authority would be met (and would probably be four). It was further noted, however, that the question of how precepting would operate had not been answered.

Philip Blundell assured the Council that Warwickshire would continue to play a role in shaping the new service and that, although West Mercia were likely to pursue a legal challenge, they were also wishing to take part in planning should the amalgamation go ahead.

Philip Blundell advised that there was a need to make sure the new arrangements fit the development of local area agreements, and the work being undertaken by the County Council in the area of community safety. These were issues that would be included in a seminar for members to be held in June.

The Chair, on behalf of the Council, thanked Mr Blundell for his report and looked forward to further discussion.

**(5) Martyn Davey**

The Chair reported that this was the last meeting of Martyn Davey, Director of Contract and Management Services. Martyn joined the Council in 1988 and used his extensive knowledge and experience to make services more businesslike and cost effective in preparation for CCT. As well as managing a range of services, Martyn also led the way in many ICT innovations.

Members thanked Martyn for the innovations he had brought to Warwickshire but were particularly appreciative of Martyn's individual attention to their IT needs and for his energetic, courteous and professional manner in which he had supported them.

The Council wished Martyn well for the future.

**(6) Buncefield Oil Depot Disaster**

Councillor Richard Hobbs (Cabinet portfolio holder for Community Safety) presented a certificate of appreciation awarded to Warwickshire firefighters who had taken part in tackling the fire on 11 December 2005.

The Council congratulated the Fire Service for this recognition and noted that the certificate would be hung in Coleshill Fire Station.

**4. Changes to the Constitution**

The Chair of Council proposed the recommendations in the report of the Strategic Director of Performance and Development, which set out changes to the Constitution as a result of statutory regulations.

Resolved

- (1) That the responsibilities of full Council and the Council's Policy Framework be as set out in Appendix 1 of these minutes.
- (2) That the Council establishes an Audit and Standards Committee as set out in the report and with the terms of reference as set out in Appendix 2 of these minutes.
- (3) That the Strategic Director of Performance and Development be authorised to amend the Constitution to reflect these changes.

**5. Appointment of Leader and Deputy Leader of the Council and Appointment of Cabinet**

**A Appointment of Leader**

Councillor Bob Stevens moved that Councillor Alan Farnell be appointed Leader of the Council. Councillor Gordon Collett seconded this proposal.

A vote was taken and Councillor Alan Farnell was appointed (23 votes for and 9 against).

## **7. Children and Young People's Plan**

Councillor Izzi Seccombe (Cabinet portfolio holder for Children, Young People and Families) presented the first Children and Young People's Plan for Warwickshire. It was noted that Warwickshire had not been required to produce a plan but had decided to do so as this provided a strong base for the planning and work of the directorate, the Strategic Board and its partners.

The Council noted that the plan had been developed with input from children and young people, and would be used as a working document to drive forward work with partners. Members discussed aspects of the plan, including the importance of parenting, involvement of all partners and performance monitoring (which should include value-added measures) to ensure outcomes were achieved.

Resolved:

That Council approves the Plan for further development in consultation with partners, stakeholders, and children, young people and their families, over the next 18 months.

## **8. Annual Report of the Standards Committee**

The Chair moved that the Annual Report of the Standards Committee be received, noting that the descriptions of the divisions represented by Councillors Sarah Boad and Mick Jones were incorrect.

Resolved

That the Annual Report of the Standards Committee be received.

## **9. Monitoring of Decisions under the Urgency and Call-in Procedure.**

The Council considered a report from the Strategic Director of Performance and Development which set out the urgent decisions and call-ins that had been considered since February 2005.

## **11. Question Time (Standing Order 7)**

### **(1) Warwickshire Waste Strategy**

Councillor John Whitehouse asked the following question of Councillor Martin Heatley (Cabinet portfolio holder for the Environment):

“ Despite Warwickshire’s Municipal Waste Management Strategy having been published, can the Cabinet Member tell me what processes are in place to ensure that emerging new technologies for the disposal of municipal waste will continue to be considered and scrutinised by the County Council?”

Councillor Martin Heatley replied:

“ We are developing a strategy that will take us into the future. There are a number of technologies around including pyrolysis and gasification. We will work in partnership with other authorities to carry forward a strategy of disposing of waste after recycling as much as possible”.

Councillor John Whitehouse asked the following supplementary question:

“Can the portfolio holder comment on the independent sustainability appraisal ‘Planning for the Future’ which recommends energy from waste through mass incineration only as a last resort. If Warwickshire were to put in one now then it would have a short lifespan, as it would be likely to be superseded by other new methods”.

Councillor Martin Heatley replied:

“ Yes, I am aware of the report. The UK Sustainable Development Commission has congratulated us on our waste strategy. The report you refer to talks of developments in the future. Mass incinerators are not on our horizons and we believe in recycling as much as possible. I am satisfied that the documents identify Warwickshire as an area where one could build a mass incinerator but that it would not be needed, which is why we are not looking at mass incineration.”

## **(2) Highways Maintenance Contract**

Councillor Jerry Roodhouse asked the following question of Councillor Martin Heatley (Cabinet portfolio holder for the Environment):

“With regards to the Management of the Highways Maintenance Contract, can the Cabinet member tell me what progress has been made against the recommendations made in the report to the Environment Overview and Scrutiny Committee in January this year?”

Councillor Heatley replied:

“The contract began in 2004 and there were teething problems and audit reports identified shortcomings. The report is still confidential as far as costings are concerned. I expect a report will go back to the Overview and Scrutiny Committee in future.”

Councillor Jerry Roodhouse asked the following supplementary question:

“Have the failings that were highlighted been remedied and when will a report go to the committee to make sure issues are rectified?”

Councillor Heatley replied:

“The Highways Maintenance Plan 2006/07 will be going to Area Committees. The Overview and Scrutiny Committee will have a report in September, but if it is possible to report earlier then this will happen. I am satisfied that the efforts of officers have borne fruit. Patching costs are down, street lighting costs reduced and the aim is that all costs are below target by next year (end of year 3 of the contract).

There were no other items of business.
