1. Background

The draft Corporate Business Plan 2007-2010, as sent out for this Cabinet meeting, was considered by Strategic Directors Management Team on 2nd May. As a result it is intended to make the following changes to the plan.

2. List of Amendments to Corporate Business Plan

- **2.1.** For publication, the appendices 1 and 2, setting out the full Corporate Report Card and LAA measures and targets, will be separated from the CBP and published as a companion document, issued in the CBP folder.
- **2.2.** All Corporate Report Card indicators which support the achievement of the top priorities, will be shown in the CBP, under the appropriate Top Priority.
- **2.3.** In Section 3 on Page 4 remove the word significant in "Locally there is pressure from the public, with significant resistance to Council Tax increases above inflation" as this year only one complaint was received from the public.
- **2.4.** Appendix 1 Page 16 Fire CPA Score target amended for 2007/8 to 3, since it was thought unrealistic to make the jump from 2-4 in one year.
- **2.5.** In Appendix 1 on Page 18 CPA Value for Money target was changed from 4 to 3 for 2007/8, since 4 cannot be achieved until our Adult Social Care CPA score is 3 (targeted for 2008/9).
- **2.6.** In Appendix 2 page 23 LAA targets, heading for Stronger Communities needs to be added.
