The reduction in looked after children is linked to Warwickshire having significantly high levels of children in care compared to statistical neighbours. The Strategic Review highlighted that there are less children coming into care but sometimes permanency takes too long. Continued work on the placement mix, particularly recruitment of foster carers but the placement mix when compared to other areas is very good e.g. we have low numbers of children in residential care.
(2) How does it fit with Warwickshire County Council's wider objectives?	The reduction in children in care is in line with desired approach of self-help and supporting families where safe to do so to stay together.
