To consider the following motions submitted by members in accordance with Standing Order 5:

(1) Climate Emergency

'That,in light of the recent reports from the IPCC 'Special Report on Global Warming' (2018); the CCC report 'Net Zero – the UK's contribution to stopping global warming' (May 2019) and the concerns that not meeting the UK's targets will have a negative impact on our residents whilst measures to combat climate change can have significant benefits, this Council recognises the role local government has to play in responding to climate change and

- 1. Declares a 'Climate Emergency' as a pledge in moving to carbon neutral targets.
- 2. Convenes a cross party group to work with officers, representatives of local environmental groups, residents and businesses, that will report to Cabinet within 6 months on what actions can be taken which should include how to achieve behavioural change, set against the targets needed to achieve reductions.
- Develops a communication strategy to convey to residents the severity of the situation, and the ways people and businesses can take independent action to cut greenhouse gas emissions.
- 4. Lobbies Government to provide the powers and resources needed to address this issue'

(2) Climate Change

'The United Nations Intergovernmental Panel on Climate Change has warned that we have 12 years to make the necessary changes to limit a rise in global temperatures to 1.5 °C. Failure to act will see a marked increase in sea levels and flooding, extreme and abrupt changes to weather patterns, crop failures, extinctions of plant, insect and animal species and global economic disruption and crisis. The significantly high levels of atmospheric pollution experienced locally highlight why this is such an important issue for Warwickshire County Council to respond to.

In response, this Council

- a) declares a 'Climate Emergency';
- b) requests that a Climate Task & Finish Group be set up to respond to the challenge;
- will work in collaboration with our District and Borough partners to develop a target and resourced proposals for a carbon neutral action plan for Warwickshire County Council to be considered by Cabinet.
- d) Will review and update its transport plans for each of the District and Borough Councils in Warwickshire, to enable a move towards building sustainable transport systems in recognition of the goal of moving towards carbon neutrality;
- e) calls on the Government to provide the resources and powers so that Warwickshire County Council can make its contribution to the UK's Carbon Reduction targets.'

(3) Women Against State Pension Inequality

'That, in light of the fact that the rise in the women's state pension age has been too rapid and has happened without sufficient notice being given to the women affected (particularly those born in the 1950s), leaving women with no time to make alternative arrangements, the Council calls upon the Government to reconsider transitional arrangements for women born on or after 6th April 1950, so that women do not live in hardship due to pension changes they were not told about until it was too late to make alternative arrangements.'

(4) Affordable Housing

'In March of this year Dominic Raab promised to consult on changes to the "Right to Buy". This Council fully supports this review and as a first step urges the Government to end the practise of taking money from the Right to Buy receipts so that local authorities can build more affordable housing in order to reduce dependency on private rentals, the majority of which are levied at a rate which exceeds the mortgageable value of the properties. This is clearly a significant factor in terms of contributing to in-work poverty and often leads to families living in substandard properties which in turn leads to health problems related to mental health issues and a deterioration in the general health and well being of those trapped in this situation.'
