3. Street Lighting Hours of Operation

Report of the Strategic Director for Environment and Economy.

At present virtually all street lights in Warwickshire operate throughout the night. Savings would be made to the street lighting energy budget by switching off all (or selected) street lights after midnight. The report provide information on the options which might be considered.

- (2) Trials to be carried out to check the effects of switching off selected lights particularly on levels of illumination.
