Re: Crisis House Development Rugby

Following on from the issues being raised through the Consultation over our plans for the development of Adult Mental Health Services in Rugby, then there has been strong support for our proposals to explore developing a Crisis House Service in Rugby.

In order to progress the proposals associated with establishing a Crisis House development, I would like to invite you to join the Project Group that can help us take forward the issues that we will need to successfully address.

I am proposing that the first meeting of the Project Group would be on Thursday 18^{th} October 2007 starting at 9.30am and probably running for about $1 - 1\frac{1}{2}$ hours.

I would propose that the initial meeting is held at the Caludon Centre, Coventry, as this appears most central and convenient for those invited.

At our first meeting I would like us to agree Terms of Reference for the Project Group and an outline programme for how we could progress issues along with the specific roles and responsibilities individuals could play within the Project Team.

I apologise if this first meeting is inconvenient for anyone, but I would hope that the 2 weeks notice, enables people to re-arrange commitments so that they can attend. I would propose that we plan and agree future meetings when we meet to make sure that they are convenient for all.

I will hopefully be able to issue an agenda and an outline of the Terms of Reference for the Project Group prior to when we meet for consideration. In the interim I enclose a copy of the Operational Policy developed for the North Warwickshire Crisis House which I would ask you all to consider, as I believe it provides a framework that we can develop for a Crisis House Provision in Rugby.

When we meet we can also agree whether there are others that should be involved in the Project Group at this point and also confirm that you believe you are best placed to represent your various constituencies.

I look forward to when we can meet on the 18th and would hope we can progress proposals for Rugby that will see a Crisis House being established and operational sometime early in the New Year.
