# Warwickshire Health & Wellbeing Board 18 September 2018 Warwickshire North Health and Wellbeing Partnership

### Recommendation:

That the Warwickshire Health and Wellbeing Board consider and endorse the update from the Warwickshire North Health, Wellbeing and Integrated Care Partnership.

## 1.0 Background

- 1.1. The Warwickshire North Health and Wellbeing Partnership (WNHWBP) was formally established in 2012 to ensure local delivery of the Countywide Health and Wellbeing Strategy.
- 1.2. The Partnership's vision is for partners and communities to work together, to ensure people live longer, healthier and independent lives for as long as possible, reducing inequalities of health related outcomes, both across Warwickshire North and between Warwickshire North and the rest of the County. This is achieved by strategic influence and local place based working.

## 2.0 Purpose

2.1 The WNHWBP has reviewed and reset its priorities as it evolves to deliver the complex challenges of the health and social care sector within the framework of the new health and wellbeing concordat, the system design model and the emerging Integrated Care System. This report provides details of its review of its key actions to date and outlines the future direction of the partnership and programme of work.

### 3.0 Two year Review: actions and achievement to date:

- 3.1 Between 2012 and 2015 the group focused on building the partnership by forming strong relationships through small but practical actions that make a difference locally. During the last 2 years the focus shifted to the added value of the partnership by working together on joint initiatives that address local issues The group has also acted as a "critical friend" to partners and at a County level highlighting and challenging local priorities.
- 3.2 The report highlights partnership successes including:
  - The Health Store funding and expansion
  - The #onething campaign

- Improving End of Life Care in Warwickshire North
- Warwickshire North a dementia friendly community
- Supporting the development of integrated hubs/clusters
- Exercise on referral
- 3.3 The work of the partnership over the last two years, has been summarised in the review document (appendix 1).

# 4.0 The Future of the Partnership: Integration and Forward Planning

- 4.1 The group has so far met bi-monthly and, to-date has comprised elected members and senior officers from Nuneaton and Bedworth and North Warwickshire Borough Council's, NHS Warwickshire North Clinical Commissioning Group, Warwickshire CAVA and Warwickshire County Council.
- 4.2 In early 2018, the group agreed to hold a workshop to invite a wider range of organisations to become a member of the group and help to shape it as it evolves to deliver the complex and emerging challenges that impact on us all, while retaining the benefits of local focus and delivery emphasis. The Partnership believe the timing is right to evolve the local established partnership to integrate working more closely with our providers and other local partners to deliver improved Health and Wellbeing for Warwickshire North's population. Also to consider if, or how, this might form one element in the evolution of a future integrated care system for Coventry and Warwickshire.
  - 4.3 On Thursday 12th April in the afternoon a stakeholder meeting facilitated by John Bewick was held to discuss the future of the partnership, its membership and priorities. The Partnership is seen locally in Warwickshire North as the 'Engine Room' that supports the County level and STP level working. There are three areas the group will lead on;
    - Improving and implementing integrated provision in the Warwickshire North footprint
    - The local place based JSNA and building the evidence base
    - Promoting proactive and preventive healthcare, through building and utilising community assets for proactive and preventative care, self help and independence

### 5.0 Financial Implications

Partnership costs are met from within the existing budgets of the member organisations. At this stage no additional costs of partnership board have been identified. Any new service costs would need to be approved and agreed by the

appropriate organisation(s).
