Warwickshire Pupil Referral Unit – Reconstitution of the Management Committee

Report of the Strategic Directors for Children, Young People and Families and Customers, Workforce & Governance

Recommendations

That the Portfolio Holders approve the draft revised Instrument of Government for the Warwickshire Pupil Referral Unit, attached as Appendix B to this report.

1. Background

- 1.1 The Warwickshire Pupil Referral Unit (PRU) is based on three sites and provides education:
 - a. full-time for pupils permanently excluded from their school;
 - b. part-time to pupils who remain on the role of a mainstream school to help improve aspects of their behaviour and learning; and
 - c. to pupils unable to attend school due to ill-health.
- 1.2 The Apprenticeships, Skills, Children and Learning Act 2009 provided that PRUs should be known as Short Stay Schools. This was expected to take effect from 1 September 2010. However, Nick Gibb, Minister of State for Schools announced in Parliament on 20 July 2010 that this requirement would be removed.
- 1.3 Governance of PRUs differs from that of other maintained schools in that it does not have a Governing Body. The Education (Pupil Referral Units) (Committees etc) (England) Regulations 2007 made it mandatory for local authorities to establish management committees for their PRU and Cabinet approved an Instrument of Government in accordance with these regulation at its meeting on 10 January 2008. The Management Committee effectively operates as the Governing Body but with some differences in responsibilities. Although Management Committees became mandatory from February 2008, Warwickshire had operated with a non-statutory committee for a number of years.
- 1.4 The Regulations provide that the statutory Management Committee should be between 7 and 20 members. There are proportionality requirements for the four mandatory categories of member (community, parent, local authority and staff). Statutory Guidance "strongly recommends" a membership not exceeding 12.

However, in Warwickshire the maximum size of 20 was adopted following representations from the former non-statutory management committee.

1.5 **Appendix A** sets out the constitution of the current Management Committee. Both the local authority and the Management Committee can propose change to the Instrument at any time and must consult with the other party where this is proposed.

2. Introduction

- 2.1 The Warwickshire PRU was inspected by Ofsted on 23 and 24 June 2010 and was deemed to require special measures. The reasons for this finding were:
 - Quality of leadership;
 - Quality of teaching and learning;
 - Quality of the curriculum, and
 - Failure to meet pupils' statutory entitlement to full-time education.

The Ofsted report was published on 22 July 2010.

- 2.2 Experience in mainstream schools is that where Ofsted identifies serious concerns about governance, it can be appropriate to replace the normally constituted Governing Body with a specially constituted Interim Executive Board (IEB). An IEB comprises a small number of specially selected governors able to bring about rapid and sustained change. Although the IEB regulations do not apply to PRUs, given the nature of the concerns identified by Ofsted, a similar approach is proposed.
- 2.3 The current Management Committee was consulted on a proposed reduction in size of the Management Committee at an extraordinary meeting held on Thursday 22 July 2010. The Management Committee accepted the need for this change and proposed a revised model comprising 12 members. The proposed new Instrument of Government which reflects this proposal is set-out in **Appendix B**. (This includes a change of base address for the PRU to Pound Lane, Leamington Spa).
- 2.4 The Portfolio Holders are requested to approve this revised draft Instrument.
