2006-07 Capital Programme for Transport – Delegated Budget – Junction at B5000 Grendon Road and Common Lane, Polesworth

Report of the Strategic Director for Environment and Economy.

A request for a modification to the junction of the B5000 Grendon Road and Common Lane in Polesworth has been made by Councillor Stanley. This scheme could be funded from the £40,000 delegated budget allocated to the Area Committee for transport projects to address local priorities. In September 2006, Area Committee requested that a consultation with local residents be undertaken prior to the scheme being included in the programme for 2006/07. Following the consultation, and in conjunction with Councillor Stanley, Option 1 has been identified as the preferred improvement scheme. It is considered that this option would have the least impact on local residents and greatly improve safety at the junction.

Recommendation

That the preferred scheme to modify the junction of the B5000 Grendon Road/Common Lane, Polesworth be included in the 2006/07 Capital Programme for Transport, to be funded by allocating £25,000 from this Area Committee's delegated budget.

6. 2006-07 Capital Programme for Transport – Delegated Budget – Street Lighting, Marston

A consultation with local people has taken place and a compromise scheme has been identified whereby new columns will only be placed where there were no objections from residents.
