Hams Lane, Lea Marston - Outcome of Public Consultation

Report of the Strategic Director for Environment and Economy

Recommendation

That the Area Committee does not support the proposal of Lea Marston Parish Council to close Hams Lane.

1. Introduction

- 1.1 The Lea Marston Parish Council has held concerns regarding the speed and volume of traffic in their village. Over the years various methods of reducing the volume of traffic in the village have been examined and found to be impractical.
- 1.2 The Parish Council in response to these concerns asked the County Council to examine the possibility of closing Hams Lane to through traffic. A map of the suggested closure is attached as **Appendix A** to this report. From the County's perspective an understanding of the level of support for such a proposal was essential before further consideration could be agreed. A consultation exercise was therefore carried out during December 2006.

2. The Consultation

- 2.1 The exercise involved surveying by post the population of Lea Marston village and surrounding Parish Councils. Officers also held discussions with other stakeholders including the emergency services and the Highways Agency.
- 2.2 Of the 81 households in Lea Marston village surveyed 58 responded. This represents 72% of the total. From these households 126 individual responses were made.
- 2.3 Other responses outside of the residents survey were received by letter, e-mail and telephone and are detailed in **Appendix B** to this report.
- 2.4 From the survey 62% (78 people) of respondents from Lea Marston were against closure of Hams Lane. All responses made outside of the resident survey were against the proposal with the exception of a letter from Lea Marston Parish Council. A majority of Lea Marston residents (62%) considered that the size of vehicles, including illegal use of HGVs in weight restricted areas,



- constituted the greatest traffic problem in the village. Other issues noted included the use of the village as a "rat-run" and the speed/volume of traffic.
- 2.5 The Highways Agency made no specific response to the proposal other than to note the limited capacity at Junction 9 of the M42 to where traffic would be displaced by a closure of Hams Lane. Should a closure be proceeded with the Highways Agency would wish to see a traffic modelling exercise that analysed in detail the effect of a closure on Junction 9 of the M42.
- 2.6 Warwickshire Police responded to the consultation and noted their concerns about the effect a closure of Hams Lane would have on their (and other emergency services) response times to incidents in Lea Marston and adjoining areas.

3. Conclusion

- 3.1 The County Council undertook the residents survey to identify if the proposal of the Parish Council to close Hams Lane had public support. Opinion was split on this with a slight preference for keeping Hams Lane open. Outside of Lea Marston village the proposal met with unanimous opposition and concern from the Police and Highways Agency.
- 3.2 In the light of the survey results and the concerns raised it is recommended that Hams Lane should not be closed.


