## 4. Highway Maintenance and Safety Budget 2008-09 – Outline Capital Allocations

Report of the Strategic Director for Environment and Economy.

At its meeting of 6 February 2007 the County Council approved a £2 million 2008-9 capital allocation to Highway Maintenance and Safety; £400,000 for each of the County's five areas. The funding is to be allocated to local schemes in consultation with Area Committees. The report makes proposals for outline capital allocations within the £400,000 for North Warwickshire area. When Area Committee has agreed the outline allocations a programme of

schemes will be prepared for discussion at the North Warwickshire Transport Seminars in January 2008.
