Nuneaton and Bedworth Area Performance 2004/05 and Area Business Plan Milestones 2005/06

Report of the County Solicitor and Assistant Chief Executive

Recommendation

That the Nuneaton and Bedworth Area Committee:

- 1. Comments on progress made against milestone targets contained in the 2004/05 Area Business Plan.
- 2. Endorses actions and milestones contained in the new 2005/06 Area Business Plan.

1. Introduction

- 1.1 The 2004/05 Nuneaton and Bedworth Area Business Plan was agreed by this Area Committee in September of 2004. It contained details of actions and milestone targets proposed for delivery by Warwickshire County Council departments in the Nuneaton and Bedworth area over a 12-month period. The plan was based around the six Corporate Objectives of the County Council and sought to illustrate the ways in which the County Council, as a strategic authority, tailored and delivered its services to address local needs. The following report outlines the council's success in delivering those actions.
- 1.2 In previous years the Area Committee has been presented with performance reports that combine information on progress against a) actions and b) performance data. Some Members have expressed the view that this approach has overwhelmed them with information to the extent that they have been unable to assimilate it all. In order to address this, the decision has been taken to focus initially on progress against actions. A report on performance against Corporate Headline Indicators will be presented to the July meeting of this committee.

2. 2004/05 Actions and Performance

2.1 Appendix A of this report details the various actions that were proposed for this area by departments almost a year ago. Within the appendix, Members will find an indication of the progress made and, where appropriate, a



commentary explaining the current status of that action. To assist the interpretation of the appendix the following is a summary of the main achievements:

Headline Achievements in the Nuneaton and Bedworth Area:

- There is an overall improvement Key Stage 2 and 3 with local results exceeding targets although results fall short of the County performance targets.
- Important capital works have been progressed in local schools and 2 new Special Schools will be completed in the Autumn term.
- Stockingford Early Years Centre and Library was completed and opened in October 2004.
- An increasing number of schools are achieving the Warwickshire Health Promoting Schools Scheme accreditation.
- Trading Standards continued to successfully focus on enforcement of under-age purchasing of tobacco and alcohol.
- Schools involved in recycling schemes are showing good progress.
- Eliot Park Innovation Centre was officially opened and looking to achieve an Excellence Award for its' environmental building standard.
- Nuneaton Development Project Phases 1 and 2 were completed and have supported other major developments within the town centre.
- Completed activities to deliver the Crime and Disorder Strategy have led to positive results relating to an impact on the fear of crime.
- Fire and Rescue Community Safety projects around Home Fire Safety and Smoke Alarms have created a substantial decrease in fires in vulnerable homes and no reported injuries.
- Major successes realised on the Car Clear Scheme for abandoned vehicles and substantial reductions in car/small fires.
- The Building Sustainable Neighbourhoods team have substantially exceeded targets relating to jobs and new enterprises within the Regeneration Zone.
- Substantial progress has been made in the Pride in Camp Hill Project Plan, including construction of new roads and homes.
- Successful Well-being Fund Commissions, Community Development Fund and Social Inclusion Fund projects identified and progressed for the benefit of local people, through the newly created Area Committee Funding Sub-group.

3. Performance Summary

- 3.1 Overall performance demonstrates substantial achievement with 75% of actions exceeded. Only 2 out of 52 actions were not achieved or substantially delayed. A few actions were nominally delayed with much of the work being achieved. Non-achievement is around GCSE results in the area, although results exceed local targets there is still further work to be done in bringing some area schools in line with County targets.
- 3.2 As previously stated Performance Data will be reported to July Area Committee and any areas of concern or particular achievements within that criteria will be reported for consideration.



4. Nuneaton and Bedworth Area Business Plan 2005/06

- 4.1 As well as reflecting on last year's performance, it is important to give regard to what the County Council will be doing in the Nuneaton and Bedworth area in this financial year. The work of the County Council is largely governed by its six corporate objectives and by the Corporate Business Plan.
- 4.2 The 2005/06 Nuneaton and Bedworth Area Business Plan takes those guiding principles and applies them to the local dimension through the identification of local needs and issues and sets out actions to be undertaken by departments to address these issues. Attached at **Appendix B** is a copy of this part of the Plan for 2005/06, which has been drafted for Members comments.
