3. Ribbonsfields, Nuneaton – Proposed Prohibition of Waiting Restrictions.

The report of the Director of Planning Transport and Economic Strategy.

Objections to proposals for waiting restrictions in Ribbonfields have been considered by this Committee at its meetings in November 2004 and March 2005. At the meeting in March Committee agreed that further consultations should be carried out. This report discusses the comments which have been received following those consultations and recommends how they should be dealt with.

Recommendation

That prohibition of waiting at any time be introduced as follows:-

- (i) The whole length of the north side of Ribbonfields access road.
- (ii) The west side of the cul-de-sac fronting No's 31-33 and
- (iii) The south side of Ribbonfields access road from a point 62 metres west of its junction with Attleborough Road west for 31 metres and from a point 131 meters west of its junction with Attleborough Road west to the end of the cul-de-sac.
