Recommendations

That the Committee -

- (1) nominate a Councillor to replace Councillor Tooth on the King Edward VI Foundation.
- (2) confirm the continuation of Don Jacques as the County Council's second representative on the King Edward VI College Foundation.

1.0 Introduction

- 1.1. The Area Committee is being asked to replace Councillor Sid Tooth as one of the two County Council's trustees on the King Edward VI College Foundation. Councillor Tooth feels he is unable to continue as the County Council representative because of his increased County Council commitments and home responsibilities.
- 1.2. The second County Council representative on the Foundation is Don Jacques (a former County Councillor) and he has indicated his willingness to continued in this capacity.

2.0 King Edward VI College Foundation - Constitution

- 2.1 The Foundation's constitution allows for 8 Trustees, (5 co-opted of these 3 are appointed by Nuneaton and Bedworth Borough Council for a fixed 4 year period and 2 appointed by the County Council until the County Council agrees to replace them).
- 2.2 The Foundation meets no more than 4 times a year at 5:00 p.m. at King Edward VI College, King Edward Road, Nuneaton (meeting dates are not set to a given timetable).

3.0 Recommendation

The Committee is asked to consider the replacement of Councillor Tooth as Trustee of the King Edward VI College Foundation and to confirm the continuation of Don Jacques.
