5. Weddington Road Cycle Scheme

Report of the Strategic Director for Environment and Economy.

It is proposed to develop a new cycle route to link the Weddington area of Nuneaton to the town centre. The proposed scheme includes widening a section of footway in the vicinity of the Leicester Road bridge and on the south of the Weddington Road to allow conversion to a shared use footway/cycleway. Early approval of this conversion by Area Committee is sought to allow co-ordination of the scheme with the programmed works on the Regent Street/Leicester Road junction as part of the Nuneaton Development Project.
