3. Nuneaton and Bedworth Social Inclusion Funding 2006/07 and 2007/08

Report of the Strategic Director for Performance and Development.

This report from the Funding Sub Group recommends that the Area Committee approves £30,169 from the remainder of the 2006/07 Social Inclusion Fund and £13,00 from the 2007/08 Social Inclusion Fund, for two projects:
