Developing the Work Programme

Report of the Strategic Director of Performance and Development

Recommendation

That the Group

- (a) Comments on the issues that should be included in the Core Work programme for 2007/08.
- (b) Requests the Strategic Director of Performance and Development to consult the Cabinet, other county councillors/Council and our key partners on the issues to be included in the Core Work Programme
- (c) Approves the criteria for selecting topics for review

Introduction

- 1. The feedback from the review was that most members felt that the arrangements for agreeing the work programme were okay or better and that the work programme reflected the significant issues facing relevant services reasonably well. However most members felt that policy was too officer driven and that there was a role for overview and scrutiny to be more pro-active and contribute to key policy issues affecting the delivery of public services.
- 2. Similarly members had a role in challenging whether our key performance targets are robust enough -do they take the council to where it needs to be within an appropriate timescale? Overview and Scrutiny Committees have received reports in the last cycle specifically asking this question and undoubtedly the new performance information system will provide an invaluable tool for assessing not only whether there is improvement but the pace of improvement in comparison with others.
- 3. A well-designed work programme contains a mixture of projects some of which require an overview to be kept of an area of the council's activity and others that will closely scrutinise a particular policy or area of work. The work programme needs to be fluid with topics being added be added to or removed from the work programme as priorities change. Occasionally an urgent matter may need to be added to the work programme at short notice.

4. It is important to remember that with the increased emphasis on partnership working, items for overview and scrutiny can be identified from a number of different sources. Elected members have a wealth of knowledge that they can bring to the overview and scrutiny table. It is very much their role to help shape the work programme as one that has been developed solely by officers may well not meet the needs of the committee or of our partners.

Developing a Core Work Programme

- 5. Whilst there was a common view that the work programme should be member led and that committees should be able to develop their own work programmes, there was an acknowledgement that there should be agreement about a core annual work programme to ensure that the key issues were tackled in a timely way and allocated appropriately. The number of items included in a core work programme should be small to enable Committees to retain some flexibility and accommodate issues that may arise during the course of the year. It should reflect the key issues that must addressed by Overview and Scrutiny over the next financial year whatever else it does.
- 6. The Council agreed a vision on 12 December 2006 this sets eight priorities
 - Giving every Child and Family the best opportunities in life and raising levels of educational attainments
 - Improving Community Safety and reducing fear of Crime
 - Promoting Healthy Lifestyles
 - Supporting Older People to live independently
 - Strengthening the Warwickshire Economy
 - Improving and Sustaining our Environment
 - Strengthening our Communities and celebrating our Heritage
 - Raising standards of Customer Service and Access to our Services
- 7. The Appendix shows the topics that currently have been identified by the various Overview and Scrutiny Committees for consideration in 2007. Some items within the Appendix may be appropriate to include in a 'Core Work Programme' for 2007/08, others may not and there may be issues not currently included which need to be prioritised as part of a core work programme e.g.
 - Directorate Report Cards
 - Medium Term Financial Planning
 - Joint Scrutiny relating to the Local Area Agreement
- 8. The Group is asked to comment on the issues which should form part of any core work programme which needs to be planned for during 2007/08.
- 9. It is suggested that it would be appropriate to consult more widely on the issues which should form part of any core work programme with both Cabinet members, other councillors/council and our partners.

Selecting Topics

- 10. Member time is finite and therefore there is a need to prioritise the topics any committee will look at. It is suggested that whether or not any particular issue will be addressed is determined using the following criteria.
 - Does this issue have a potential impact for significant section(s) of the population?
 - Is it a matter of general public concern?
 - Is the issue to be reviewed a key deliverable of a strategic and/or partnership plan?
 - Is it a key performance area where the Council needs to improve?
 - Is there a legislative requirement to undertake the review?
- 11. Secondly if members want to ensure that reviews add value/ make a difference members will also need to consider whether it is practicable to undertake the review by asking the following questions-
 - · Are there adequate resources available to do the activity well?
 - Is the overview and scrutiny activity timely?
 - Is there a clear objective for scrutinising this topic?
 - Is there evidence to support the need for overview and scrutiny?
 - What are the likely benefits to the council and its customers?
 - Are we likely to achieve a desired outcome?
 - What are the potential risks?

Reasons to Reject Items for Overview and Scrutiny

- 12. There will sometimes be very compelling reasons why an item should not be subject to overview and scrutiny. Most commonly this arises where
 - An issue is being examined elsewhere e.g. by the cabinet, working group, officer group, other body
 - An issue was dealt with less than 2 years ago
 - New legislation or guidance is expected within the next year
 - There is no scope for overview and scrutiny to add value/ make a difference

- There is a risk that the objective cannot be achieved in the specified timescale
- 13. If members consider the criteria for selecting topics is appropriate it may wish to recommend that Committees have a fresh look at their work programmes against the criteria to ensure they are maximising the use of their time.
