#### **Decision Taken**

The Portfolio Holder for Finance and Property gives approval to add the following four schemes to the 2016/2017 capital programme subject to the applicable Section 278 Agreements with the Developers being signed which will provide for 100% of the funding.

- A422 Alcester Road, Stratford-upon-Avon access to development and relocation of Toucan crossing. Developer Taylor Wimpey Midlands. Approximate cost £225,000.
- A426 Southam Road, Southam access to quarry at Griffin's Farm. Developer CEMEX UK Cement Limited. Approximate cost £245,000.
- A428 Lawford Road, Rugby right turn lane and access to development site.
   Developer Stepnell Limited. Approximate cost £190,000.
- B4429 Ashlawn Road, Rugby new Puffin crossing. Developer Bovis Homes Central Region. Approximate cost £150,000.
