Background Information

Since 2010, Warwickshire County Council (WCC) has been a participant in a sub-regional (Coventry City Council (CCC), Solihull Metropolitan Borough Council (SMBC), WCC) contract lead by CCC for the provision of a media advertising service primarily used for the publication of job advertisements and statutory public notices. This contract is also used by Warwickshire schools. The decision to participate in a collaborative contract was taken to protect the Council's media discount levels at a time when there was a definite and continuing trend of reducing expenditure in this area due in the main to a reduction in recruitment advertising and the shift towards advertising job opportunities on specialist job-boards and the Council's internet site. Participation in the sub regional contract has had the intended result of protecting the Council's media discount s at previous levels. The existing sub-regional contract is due to expire on 30/11/2016 and no further contract extensions are available. The sub region is therefore preparing itself to re-tender this service on a collaborative basis with a new contract expected to be in place from 01/12/2016.
