Decision Taken

That the Portfolio Holder for Transport and Planning approves that the Warwickshire County Council (District of Stratford on Avon) (Civil Enforcement Area) (Waiting Restrictions, on Street Parking Places and Residents Parking) (Consolidation) (Variation No 19) Order 2013 be made as advertised.

Reasons for Decisions

Proposals for parking restrictions in various locations in the Stratford-upon-Avon District were published in the Stratford Herald and Alcester Chronicle on 5 September 2013. Minor modifications to those proposals were also published in the Stratford Herald on 26 September 2013. The report considers the objections and comments that were received and recommends how they should be dealt with.

A number of proposals included in the consultation did not receive any objections and it is recommended that these be implemented as advertised.

The proposals which attracted objections are in the following locations:

- High Street, Bidford-upon-Avon Proposed Double Yellow Lines i)
- Blackthorn Road, Blue Cap Road, Tower Close and Walkers Road, Stratfordii) upon-Avon – Proposed Double Yellow Lines and Single Yellow Lines
- Saxon Close, Stratford-upon-Avon Proposed Double Yellow Lines iii)
- Baker Avenue, Brookside Road, Brookside Close, Drayton Avenue, Masons iv) Way and Meadow Close, Stratford-upon-Avon - Double Yellow Lines
- Springs Crescent, St James Road, St James Crescent and Welsh Road V) West, Southam – Proposed Double Yellow Lines
- Welsh Road West, Southam Proposed Double Yellow Lines vi)
