Decision Taken

That the Portfolio Holder for Transport and Planning approves that the Warwickshire County Council (District of Stratford on Avon) (Civil Enforcement Area) (Waiting Restrictions, On Street Parking Places and Residents Parking) (Consolidation) (Variation No 20) Order 2014 be withdrawn and that no further action is taken.

Reasons for Decisions

St Peters Way and Spillers Close are residential roads situated off Bishopton Lane to the west of Stratford-upon-Avon. The estate is adjacent to the recently constructed Stratford Parkway. Commuters are parking around bends and close to junctions causing obstructions to traffic. In the interests of road safety, Warwickshire County Council proposed to introduce sections of 'No Waiting At Any Time' upon sections of both of those lengths of road.

Due to the number of objections received, the elected member's comments and the considered unsuitability of a single yellow line restriction, the recommendation is that the advertised proposals be withdrawn and that no further action is taken.

Background Information

Proposals for parking restrictions (no waiting at any time) in St Peters Way and Spillers Close, Stratford upon Avon were published in the Stratford Herald on 27 February 2014. Ten objections were received.
