Avon Valley Indoor Bowls Club is a not for profit, member funded, community sports facility serving the residents of South Warwickshire since the early1980's. The club lease expires in 2021 and landlord Jaguar Land Rover (JLR) were initially adamant that the lease would not be renewed. Following significant interventions by Jeremy Wright MP and Cllr Izzi Seccomb, JLR have stated that the lease can only be renewed on condition that a new road access be created. The access road is a minor junction with very low traffic flows - almost all traffic being outside peak hours. Construction of the road is critical to the survival of the club but the approval process has been extremely long due to the need for a TRO and a lengthy debate regarding the option for bollards in the middle of the B4100. Timescales are critical to the club for two reasons - (i) the selected contractor has discounted the construction price, based on managing this project whilst also on-site undertaking works for JLR. Further delay to the S278 agreement may cause a significant and potentially unaffordable increase to costs which could be much greater than the fee relief granted by WCC; (ii) the bowls club access road is dependent on re-use of a Severn Trent temporary road which will otherwise be removed in February 2019. Uncertainty regarding the club's future has now dragged on for several years and this has been a huge drain on the time, energy and financial resources of the club. Avon Valley Indoor Bowls Club is desperately keen to get the road opened and return to the business of providing a great recreational facility for South Warwickshire.
