

## Decision Record – Various Roads, Stratford-on-Avon District – Proposed Waiting Restrictions, On-street Parking Places – Variation 03

<b>Decision Taken</b>
That the Portfolio Holder for Transport and Planning approves that the Warwickshire County Council (District Of Stratford-on-Avon) (Civil Enforcement Area) (Waiting Restrictions, On Street Parking Places and Residents' Parking) (Consolidation) (Variation 03) Order 2018 be made as advertised.

<b>Reasons for Decisions</b>
Where objections have been submitted to a traffic order the matter must be considered and decided on by the Portfolio Holder.

<b>Background Information</b>
Proposals for waiting restrictions both new and revised along with disabled bays at various locations in Stratford District were published in the Stratford Observer Newspaper on 26 July 2018 and consultation was carried out in accordance with statutory procedure.
The following proposals received objections; however they will be implemented as advertised, these are discussed in sections 2 & 3 :
