Dear Mr and Mrs Bartholomew,

As you are aware the implementation of a traffic signal controlled junction at the access to the site is a planning condition (Warwick District Council planning reference W/16/2172) and the approved plans do not include the requirement for a controlled pedestrian crossing on Banbury Road. The planning application submitted anticipated that the existing uncontrolled facilities at the refuge island on Banbury Road and at the roundabout at Myton Road would be used for those pedestrians accessing the school site from Banbury Road (including those walking from Bridge End) or Myton Road as is currently the case, as well as providing the new uncontrolled crossing at the traffic signals. You may wish to refer to the Transport Assessment and Travel Plan documents which can be found on the District Council's planning portal for more information.

The operation of the traffic signals will depend on the traffic demand on the different approaches. If there are no vehicles wishing to turn in to or out of the Warwick School site then the main Banbury Road southbound will remain on a green signal. The Banbury Road northbound will be constantly on a green signal because there are no conflicting traffic manoeuvres.

I have spoken with a colleague and he has made me aware that the future signalisation of the Banbury Road / Myton Road junction may come forward as planning gain from development elsewhere in Warwick and this is likely to include pedestrian crossing facilities. However, there are no timescales that I can give you at the current time.

I will report your comments, and those received from other members of the public, to the Portfolio Holder for Transport and Planning at a forthcoming meeting, probably at his meeting of 12 April. He will consider whether there are exceptional or changed circumstances which should be referred back to the planning authority for their consideration. I am writing on behalf of myself and my husband, Charles Bartholomew as residents of Bridge End who will be greatly affected by the traffic lights proposed on the Banbury Road at both the Warwick School / King's High / Warwick Prep entrance and the junction with the Myton Road. Their introduction will result in three sets of lights within four hundred metres, giving rise to more stop-start traffic, pollution from stationary vehicles and difficulties getting into and out of Bridge End.

There seems to be no reason why the lights at the Warwick Schools entrance should operate twenty four hours a day, seven days a week. If they were set to operate only at school arrival and departure times and only in term time, traffic could flow more freely at other times, easing what will inevitably be a complex traffic situation.

With this added complexity, there is a much greater need for a controlled pedestrian crossing over the Banbury Road south of the Myton Road junction. Ideally it should be at that junction, for people crossing the river bridge by the pavement on the west side, and to reduce the attractiveness of Warwick School parents using Bridge End as a quicker drop-off point and then driving through it.

We would be happy to discuss the points raised here at any time.

We are writing this e-mail regarding our concerns around the Proposed Traffic Signal at the entrance of Warwick School off Banbury Road.

We live across the road from the proposed signal by Warwick School in Bridge End.

Every morning we see a constant flow of children crossing the road from the Bridge End side to the Warwick School side, and back again at the end of school.

These children are not just attending Warwick School but also other local schools such as Myton and Cotten End Primary.

We are concerned that there is no controlled pelican pedestrian crossing as part of the proposed traffic signal plans.

This is a cause of concern regarding children and elderly adult safety crossing the road. This concern will increase with the rise in children numbers that will be attending the new Warwick School campus in the near future.

Firstly this proposal does not appear to take any account of the fact that there is a separate proposal to install traffic lights at the Bridge End/Myton Road/Banbury Road island as a traffic mitigation for the Asps development.

This together with the Gallows Hill junction means that we will have three sets of traffic lights in close proximity to each other! How will that work?


Secondly I cant understand why there is only an <u>uncontrolled</u> crossing to the Banbury Road. Have you any idea as to the present volume of traffic on the Banbury Road let alone when the impact of transferring all Warwick School/Kings High School traffic and the traffic from the Gallows Hill development onto the Banbury Road. The expected volume of school children warrants a safer arrangement.

Thirdly it is obvious to me that Bridge End will become a rat run with parents dropping off their children to try and dodge the inevitable chaos.

Fourthly there obviously needs to be some joined up thinking otherwise the traffic will just grind to a halt and I fear that Bridge End will yet again bear the brunt of it as it already does with parking problems that no body from the Council will address.

I am a resident of Bridge End, Warwick and am concerned re the potential impact of traffic congestion on the Banbury Road (now) and when the new Kings High School build is open.

You will be aware that the Banbury Road is very congested during the morning and evening rush hours. I am interested in the results of environmental, pollution testing on this road, especially on the bridge. Please inform me of these.

As a resident of Bridge End with a dog, I walk to the park daily. Crossing the Banbury Road is fraught, at many times of the day but especially during the rush hours. There was a death on the bridge last year. There is no provision for walkers to cross.

I am keen to understand what strategies, Warwick CC are to implement to minimise extra traffic coming south over the bridge on the Banbury Roaf before the new High School opens.

My concerns are -

The environmental impact Pedestrian safety Flow of traffic Increased traffic using Bridge End as a through road.

Has there been any consideration of drop off areas? E.g. - open up Myton Fields for cars to drop off pupils morning and evening, using St Nicholas car park to the same end and for pupils to walk over the bridge to their school. A win win for health of the pupils, traffic flow and environmental impact.

wrote:

I'm writing to you to register my deep concern at the existing plans for a pedestrian crossing on the Banbury Road in Warwick near the new school entrance.

We discovered recently that the crossing only operates for those already on the Eastern footpath, and makes no provision for stopping traffic heading North into Warwick on the Banbury Road.

Currently there is a much-needed (and frankly not adequate) crossing island. With the addition of traffic lights immediately to the South of these, attention of drivers heading into Warwick will be on that set of lights and not on the island; it's my understanding that the left lane (straight on) will be permanently on green and will not stop traffic for those wishing to cross the Banbury Road.

I am also concerned that the traffic exiting the school entrance will be directed to turn Left only; given the queues in the morning, I expect this to lead to further traffic problems. Parents who come South from Warwick will not want to be directed further South until they can turn around and, joining the back of the queue, face a lengthy wait to return through Warwick as many will have jobs to go to. Rather I expect Bridge End, and other neighbouring streets, to become clogged up as "dropping off points" for children whose parents want to avoid this delay by not entering the school grounds.

This will further exacerbate the problem of the lack of crossing.

I would like to see the new traffic lights / crossing be phased such that there is a controlled pedestrian crossing for the Banbury Road, and also such that cars exiting the school are allowed to turn right.

I am aware of the need to reduce traffic through Warwick, and I would like to see that myself, but the plans as they currently stand will just encourage further avoidance by drivers, quite side-roads becoming dangerously over-trafficked, and instances of confrontations shooting through the roof. I believe further work is required on a broader traffic management plan for Warwick which takes into account the poor design of traffic flow for junctions 13 and 14 which encourage people to travel through Warwick. Provision of Northbound access to the M40 from Junction 13 would, I believe, significantly ease the bottleneck of all Northbound traffic joining at junction 14 into traffic already concentrated on the inside lanes for almost immediate exit at Junction 15.

Dear Ms Reynolds

I would like to convey concerns that I have over the section of Banbury Road near to the new entrance to Warwick School. I am a resident of Bridge End with school age children.

We are extremely worried about the increased traffic and numbers of children crossing on what is already a dangerous stretch of road. Safe crossing places and traffic calming measures are paramount to avoid further fatalities on the Banbury road. As you are probably aware there have been several road traffic accidents resulting in serious injury and in one case last September, a fatality.

I have witnessed on many occasions traffic coming from Warwick town centre "flying" rapidly across the roundabout with Myton Road without paying any attention to cars coming out of Bridge End or pedestrians attempting to cross. As many cars then exceed the speed limit going south on the Banbury I expect this to cause accidents where children are attempting to cross by the proposed school entrance where I understand there will be no controlled pedestrian crossing.

I am writing to raise my concerns about the proposed introduction of Traffic Lights on the Banbury Road as detailed above.

My concerns fall into 3 headings.

1. Increased traffic congestion on the Banbury Road

2. Likely increase in traffic and parking in Bridge End

3. Future potential alterations to the current roundabout at the north end of Bridge End and the Myton Road as part of the ASPS planning application.

Increased traffic congestion on the Banbury Road

What analysis of data has been carried out which has led to the decision to introduce the proposed set of traffic lights at the newly created entrance/exit to Warwick Schools? What other options to control the additional vehicle movements were considered?

The Banbury Road towards Warwick is already grid locked around 5 pm at the current set of traffic lights at the junction with Gallows Hill Road when the employees from the Technology Park leave work. Will the proposed new set of traffic lights be operational 24/7 and 365 days a year or will they only be operational during school hours in term time? This is important to know when trying to understand how their introduction will affect the traffic flow on the Banbury Road. It would seem to be sensible to have them only operate during school hours in term time.

As the new lights will be within a few yards of the Gallows Hill Rd lights I assume they will be sequenced with each other and if so how will it work? As I said above the current lights are already grid locked at peak times.

What will happen to the current refuge for right hand turns into the south end of Bridge End? It is unclear from the drawing how this will be incorporated into the new layout. This refuge works well now and should be retained.

What actions are the Warwick Schools planning to introduce to minimise the number of additional car movements when Kings High relocates in September? Are they going to increase the number of school buses, encourage car sharing, encourage pupils to walk or ride bikes and maybe even consider a park and ride scheme. Will all the schools have the dame start and finish times or will they be staggered? Will introducing lights to facilitate easier access to the schools actually increase the number of parents taking and collecting their children from school? I would really be interested to know what the School's position is on this.

If however, the lights do go ahead it would seem sensible to incorporate a controlled pedestrian crossing to ensure pupils and others needing to cross the road during the peak usage times can do so safely.

There is no mention on the drawing of what will happen, if anything, to the entrance/exit on to the Myton Road. Does the new traffic light controlled entrance/exit replace this? If so then congestion will be even greater. Currently the Myton Road is tailed back for hundreds of yards from around 3.30 pm when the school day ends. This is so bad that I plan my journey along the Myton Road to avoid it during that time.

There are 700 extra pupils accessing the new campus and the head has said that 400 pupils have applied to go to the girls school this year so it appears there is no negative effect of the girls school moving due to the high amount of applicants it remains a popular school.Many pupils live in many of the surrounding villages and are not always able to use the bus service.Many of the sixth form girls currently park at the back of Smith Street which I assume they will no longer do.

"Parking will be relocated and extended in order to provide around 500 spaces with appropriate pick-up and dropoff areas for parents and buses."

There is no mention of the impact of traffic entering in to the site.

I just feel that the school should have some accountability for the impact of the traffic and it seems that this may have possibly been over looked when the plans were made for the school.

It is just a worry that traffic already queues on the Banbury road to go in to the Prep school at present and is stationary at school times as parents try to turn in to the school.

The other concern is the speed at which the traffic flies along the Banbury road and over the bridge in to Warwick when the traffic does subside as often frustrated motorists who have been sitting in their cars from the M40 and from the tech park see an opportunity to then speed once the traffic does abate.

The impact is already apparent and is only going to accelerate not just for the residents of Bridge End but also

- This proposal refers to an Uncontrolled Crossing which implies no proper traffic light controlled crossing facility. This must be provided. It is particularly important for parents/children crossing to and from the school. There will be around 700 extra pupils accessing the new campus. There are a number of Warwick and King's High School students living in Bridge End apart from other students needing to cross the Banbury Road.
- 2. We are concerned that without proper signage and management parents will avoid entering the school circulatory system and use Bridge End as an unofficial dropping off and collection point. This is already happening before the substantial increase in student numbers brought about by the opening of Kings High School on the site. The School should be required to provide parking marshalls in Bridge End at School arrival and departure times. Dear Shirley,

I live in Bridge End and am concerned about the impact the proposed new Banbury Road entrance to Warwick School will have on my family. The A425 is already a very busy road - in particular around the Banbury Road/Myton Road/Bridge End roundabout at school drop-off and collection time - and the strong likelihood is that it will get significantly busier following the opening of the new school entrance.

I have three young children and already find it difficult to cross the road safely. My children go to Coten End School and we commute on foot, and therefore we need to cross the A425 at its busiest period. We either do this on the north side of the Banbury Road/Myton Road/Bridge End roundabout 25/02/2019

(i.e. on the approach to the bridge); or else we cross just south of the roundabout (which is marginally easier because there's an island in the middle of the road) and then cross the Myton Road.

Given the likely adverse impact the new Banbury Road entrance to Warwick School will have on my family and other residents of Bridge End, I strongly encourage you to consider ways to make it easier for residents of Bridge End - particularly those with young children, the elderly and other vulnerable people - to cross the A425 at the roundabout. Would it be possible to install a pedestrian crossing of some sort, ideally on the north side of the roundabout (i.e. on the approach to the bridge)? Or could a traffic light system be installed on the roundabout, which would make it safe for pedestrians to cross the road on all four approaches?

Given the likely increase in traffic over the already very busy bridge into Warwick, it may also be prudent to consider some form of railings between the pavement and the road. The pavements are narrow and so walking along them with small children is already a fairly stressful experience - and it will only get worse with the increase in traffic.

If the ability to commute safely on foot from Bridge End isn't improved, there's a chance that I'll feel the need to drive my children to school, rather than expose them to the risk of walking - thereby further exacerbating the congestion issue. This would obviously be a terrible outcome, and one that I'm extremely keen to avoid.

In addition to the above safety-related concerns, I am also concerned about the potential for Warwick School parents to use Bridge End as a drop-off zone for their children. Thought should be given as to how to mitigate this risk.

I hope the above comments are helpful. Please feel free to get in touch if you'd like to discuss my concerns in more detail.

We would like to raise our concerns about the current scheme to add traffic lights at the entrance of the new Kings High site on the Banbury Road, Warwick. We live on Bridge End and our two daughters attend Kings High. Obviously we are very happy with the wonderful new school and facilities that will be added to the site, however we are concerned that whilst we understand from experience the need for traffic lights to control traffic entering the site from Banbury Road, the opportunity has not been taken to add a controlled pedestrian crossing across Banbury Road.

This has always been a difficult point to cross for Bridge End children, slightly improved I believe some years ago when residents where successful in getting approval for a traffic refuge in the centre. However the move of Kings High to the new site presents a completely different and greater safety challenge to the children crossing the road.

Obviously there will be a significant increase in the volume of traffic turning into the site from both directions, with the campus effectively doubling in size. There are also many parents who choose to drop off their children at either end of Bridge End to avoid having to enter the school site, these children then have to make their way across the Banbury Road. I am quite sure this behaviour will only increase further. Finally, the junction itself will be significantly more complicated, with one half of the road having continuous moving traffic and the other having the traffic controlled by lights. As no crossing is planned, I assume these lights will give no indication to pedestrians as to when it is safe to cross, leaving children to judge when the lights are on red and when they can take their opportunity.

Particularly on a school site, I would have thought childrens safety would be paramount and therefore I cannot see

I have read a number of documents pertaining to various changes that are proposed for the A425 leading out of Warwick towards Banbury.

I am concerned that none of the proposals include provision for a pedestrian crossing of the road.

Given the number of people who currently cross the road south of Warwick - to get to the schools (Warwick Prep, Warwick School, Warwick Junior School, the new King's High, Myton, and Coten End), the Technology Park, and Myton Fields - it would be extremely sensible to include a pedestrian crossing at the entrance to Warwick School.

I have crossed the road at least twice daily for the last 15 years and have become increasingly aware that the current refuges by the southern entrance to Bridge End and by the mini roundabout near the bridge are insufficient to ensure pedestrian safety.

I appreciate that traffic flow needs to be at a good pace, but pedestrian safety, especially of children, is also a key concern.

As residents in Bridge End we wish to make comments and objections to the above proposals as follows:

1. We can only assume that the traffic signals proposed are to facilitate the entry and exit to/from the Warwick School site by parents wishing to drop off and collect their children. The effect of these signals will inevitably result in other road users suffering considerable extra delays as they will have to wait while the Warwick School parents enter and exit the site. At present there are no such signals and the Warwick School parents have to wait until there is a gap in the traffic or another road user allows them access onto the Banbury Road and we feel that this arrangement should continue. By facilitating the entrance and exit to/from the site, parents are being <u>encouraged</u> to drop off and collect by car rather than being <u>discouraged</u> and using other means such as buses and other public transport. We feel that additional queuing as a result of drop offs and collections should be on the Warwick School site rather than on the Banbury Road.

2. As there appear to be no arrangements for a controlled pedestrian crossing the existing pedestrian refuges at the southern end of Bridge End and to the north of the proposed new junction should remain in situ.

Warwickshire County Council - Proposed Traffic Signal Junction on Banbury Road at the Entrance of Warwick School

Summary

This junction seems completely inappropriate in the way that it is implemented and is likely to cause both increased congestion and increased hazards for road users. I therefore raise an objection to its installation. The reasons for this opinion are detailed below.

Traffic

The only users who stand to benefit in any way from this junction are northbound vehicles turning right into the school and vehicles leaving the school and turning southbound (the only way permitted on the plan as provided). However, these are fairly marginal advantages and the junction is little different from, say, the nearby Bridge End junction which does not seem to warrant similar treatment. Southbound vehicles turning left into the school can already do so easily, without the need for traffic lights.

The Banbury Road is already highly congested at peak times in the mornings and afternoons, and this situation can only get much worse with increased school traffic following the move of King's High School and the massive housing developments to the south of Warwick. The introduction of an additional set of traffic lights purely to make entry to and exit from the school a little easier for some users will cause additional delays in both directions with no gain for the majority of the local population.

While the left-turn-only exit from the school would be welcomed if it reduced traffic through the town, its effect in practice will be to force Warwick-bound vehicles to loop around the toll-house island to reverse direction, thus increasing both northbound and southbound congestion on the short stretch from the school to Gallows Hill. The toll-house island does not have the capacity to allow many vehicles to use this loop effectively at any one time, and tailbacks on to the Banbury Road are likely. It may be that WCC has plans to change traffic flow around this island, but these have not been published. In that respect, it would have been far better for WCC to produce a holistic view of the three junctions from Gallows Hill to the Myton Road to allow an overall assessment of its plans, rather than the using a piecemeal approach.

Pedestrians and Cyclists

The diversion of the existing cycle-way/footpath to form a Toucan crossing seems to be a disastrous plan. Forcing cyclists and pedestrians to be compressed together into a narrow, staggered junction as shown would be very hazardous for both, even if it were used correctly. However, it is far more likely that many cyclists and pedestrians would cross in different, unintended, ways.

Few cyclists are likely to divert from the incoming cycle path and wait for two Toucan crossing light changes (as the staggered junction implies) before being able to carry on. A far more likely scenario is that southbound cyclists would divert on to the Banbury Road before the junction and re-join the cycle-way afterwards, which would be hazardous both to them and to other road traffic.

It is also likely that many pedestrians would skirt the junction at the Banbury Road edge to avoid being diverted. Even those who did divert to the Toucan crossing would be unlikely to wait for two light changes if they could avoid it and are very likely to weave between the (inevitably) queued traffic against the pedestrian lights. Both of these actions are clearly hazardous, and a more sensible solution would be to retain the crossing in its existing straight line on the current cycle-way/footpath, which people would then use. As a pedestrian user of this route over many years I would feel far more safe crossing in a straight line at that point.

The NPPF advocates that priority should be given to pedestrians and cyclists – this is clearly not the case in the design of this junction which aims to get traffic in and out of the school as quickly as possible.

The proposed uncontrolled crossing on the Banbury Road is also inappropriate. Whereas this could be made safer by having full traffic light control, this would again cause delays. However, it is in the wrong place for most pedestrians wishing to cross the Banbury Road.

The existing refuge between Bridge End and the existing school entrance is just as useful for pedestrians heading for the school and it is essential for access to the southbound bus stop across the road from Bridge End. Forcing bus users to make a significant detour along the road to use an uncontrolled crossing at the proposed lights would be unacceptable to many elderly people and would again lead to unsafe crossing practices. The solution would seem to be to make the existing crossing point safer (although as a regular user of this crossing/refuge it appears to work quite well at present). Whatever the outcome of the school junction design, it is essential that this crossing point should be retained in its present position.

Traffic Speed

There are basically two main scenarios for traffic on this part of the Banbury Road, which are unlikely to change: the morning and evening school/rush hour periods when traffic is slowmoving or stationary, and the remaining periods when the road is clear and traffic travels at excessive speeds (I remember that when a traffic survey was carried out some years ago, a typical speed for a vehicle entering the 30 mph zone was found to be about 45 mph).

The addition of traffic lights at Warwick School is unlikely to make a great deal of difference when traffic is queued but would tend to increase the excessive traffic speed when the road is clear, as vehicles aim to get through the lights whilst they remain on green. If a third set of traffic lights were added at the Myton Road junction, which I understand is under consideration, then the long straight run all the way from the Castle Bridge to beyond Gallows Hill is bound to make matters worse. Since speed limits are largely unenforced and ignored (as the 20 mph limit in Warwick has shown) traffic calming measures are the only sensible solution to make the Banbury Road more safe for all users.

Another effect of traffic lights is that they tend to focus drivers' attention on the lights themselves rather than on other road users, again increasing the hazard for pedestrians hoping to cross the road. Also, drivers who are passing through green lights are much less likely to give way to pedestrians using the refuge points a few metres further on. As a regular user of the current crossing arrangement, I have always found many drivers to be courteous in allowing pedestrians to cross at the refuges by slowing down or stopping – this is unlikely to be the case if traffic lights are introduced nearby.

All of this leads me to the conclusion that the proposed traffic lights are unnecessary and undesirable, and traffic calming measures to regulate traffic speed and assist safe access and egress at junctions would be a far better solution. Examples would be ramps at the existing refuge crossing points with a different, clearly defined, road surface. A similar ramp on the cycle-way/footpath at the school entrance, with appropriate give-way markings to favour cyclists and pedestrians, would also make a safer and far more acceptable crossing there.

Conservation

One element that seems to be given little consideration in road design is that we live in a conservation area, and the southern 'green approach' to Warwick, until recently uncluttered by an excess of street furniture, is one of the many attractive features of the town. It saddens me greatly that this approach might be disfigured by possibly three sets of traffic lights in succession, along with all the associated paraphernalia. Surely, in a town fuelled by tourists, this should be an important consideration in the design of the roads entering and leaving the town? Unobtrusive road calming measures as suggested above as an alternative to multiple traffic lights must be a more acceptable solution.

If my suggestions are not considered seriously and traffic lights are to be introduced, then it is also clear that they are only needed around school start and finish times. It would therefore be appropriate to make them part-time signals, switched off at other times when neither the traffic flow nor the pedestrian use of the roadway has any need for them. This at least would improve the appearance of the approach from the south. Part-time signals, when not in use, also have a natural effect of slowing down traffic as drivers approach them with less certainty, which would improve safety as a by-product.

I live at

I would like to register my concerns about the plans for Traffic lights at the entrance to Warwick School from Banbury Road.

My concerns are the following:

1. There appears to be no provision for a pedestrian crossing at these lights. As someone that tries to cross the Road at this point regularly in the mornings around school time, I can tell you how difficult this is. With the extra volume of traffic caused by Kings High School moving to the Warwick Boys School site, and eventually the extra traffic from the building of all the new housing along the Rd, crossing the road will be almost impossible without a pedestrian crossing.

2. Every morning parents from Warwick Boys use Bridge End to drop off their children, rather than drive through the

congested school system. This means that the children have to cross the road to the school where the traffic lights are going to be. Again, with the traffic at the moment it is a very dangerous place for children to cross and with the extra volume of traffic, this danger will increase.

3. Parents drop the children right on the corner or just inside Bridge End where there is no pavement. I have witnessed many occasions where the children have to get out of the way quickly as the next car to drop off comes around this blind corner.

The parents then proceed to do a three point turn in the road which again is so dangerous, or they use our private driveways to turn. I have been out and spoken to at least 5 parents about this.

4. Although there are yellow lines along the first part of Bridge End, these are not monitored by traffic wardens very often at all, and so this does not deter parents from using this area as a collection point for their children in the afternoon. Again meaning the children have to cross over the busy road with no pedestrian crossing.

5. The parents that don't turn around use Bridge End to drive round to the Island at the other end. This causes an increase in traffic in an area with no footpath at the time when children are walking to and from school, which is a very dangerous situation.

6. The residents of Bridge End have no pedestrian crossing to get their own children across to the local schools. I regularly see residents walking with their children to school as the cars come dashing around this blind corner. This is an accident waiting to happen.

I hope you can see fro my above points that a pedestrian crossing really does need to be incorporated with the planned traffic lights at the entrance to the school before accidents happen there. Also that something needs to be done about Bridge End being used a drop of place for children attending the school, putting them and others in danger.

I look forward to hearing from you on the above points.

Yvonne and I live at . . We have read with interest the plans for the traffic lights at the new junction with the Banbury Road and the entrance into and out of Warwick Schools. As you know this is a very busy road with varying traffic density, but particularly in the morning and again in the afternoon and early evening. With the continual increase in housing south of Warwick and Learnington and the new arrangements for Kings High School this density will increase. There is tendency for some motorists to increase their speed on the straight Banbury Road. I would like to make the following suggestions:

1. The 20 mph town speed limit which currently expires by St Nicholas Church be increased out of Warwick along

the Banbury Road up-to the traffic lights by the Gallows Hill junction. Thus making the area safer in the vicinity of Warwick School.

2. At the new proposed traffic light junction with the school on the Banbury road that a pedestrian crossing is incorporated into the traffic lights, similar to that on the Myton Road.

3. As pressure will be increased on the use of Bridge End that consideration be given to a residents parking permit to reduce congestion and the use of non-resident parking.

I should be interested to know if there are any proposals to modify the roundabout at the junction of Myton and Banbury roads. This junction is difficult for traffic flows and for pedestrian and bicycle traffic. There have been several accidents in recent years and many near fatal situations.

1 The proposal refers to an Uncontrolled Crossing which implies no proper traffic light controlled pedestrian crossing facility particularly important for parents/children crossing to and from the school—remembering there will be around 700 extra pupils accessing the new

campus. What do you anticipate will be the impact on the immediate and surrounding areas ?

2 There is concern that without proper signage and management parents will avoid entering the school circulatory system and use Bridge End as an unofficial drop off point. Is the school aware of the potential problem and looking at possible solutions such as parking marshalls in and around Bridge End / Myton Road and drop areas further away such as main Sainsbury's or the racecourse being used as a park and ride ?

3 The volume of traffic in and around Bridge End will greatly increase from September and there appears to have been little consideration of this by WCC ?

4 There will of course be disruption during construction of the new junction. Please can you confirm when the works are to be carried out—presumably during the summer holidays?

5 Is the existing pedestrian refuge by the southern entrance at Bridge End going to remain in situ?

6 Surely WCC will consider extending the 20 MPH speed limit to include the section of Banbury Road outside the school and to include the new traffic light junction?

Currently, traffic speed is excessive when there is a free run & the 30mph is being exceeded. I believe it is not a matter of if but when we see another fatality - why wait ?

I live at and an writing with my views on the proposed alterations to the Warwick School entrance that is currently the subject of a public consultation exercise. I am not convinced there has been any real assessment of the inevitable increase in traffic on Bridge End itself.

My comments are as follows:

1 It is noted that there is a controlled crossing at the entrance to the school but across the Banbury Road itself the crossing is uncontrolled.Surely with the number of children crossing the road safety must be the priority and in my view there ought to be a controlled crossing here as well. I think there is a broad concensus that the new junction is acceptable in principle but it must include fully controlled traffic lights for the benefit of pedestrians particularly children.

2 The fact that there will be around 700 more pupils at the new campus will mean inevitably there will be more children and parents crossing the Banbury Road also not forgetting the many people who walk through Bridge End to and from the Technology Park.

3 Despite the presence of yellow lines at the southern end of Bridge End parents use this as an unofficial drop off point for the school which will inevitably increase from september.Residents in Bridge End are concerned that parents will avoid entering the school circulatory system and will use Bridge End as a rat run/unofficial drop off point in order to save time.This will greatly add to the numbers crossing the Banbury Road to access the school.

4 The yellow lines at the southern end of Bridge End should be extended around the corner to help deter parking in Bridge End by parents and workers employed at the technology park—there needs to be better enforcement by the council as well as they are ignored at the moment. This will get worse from september.

5 Can you clarify whether the existing pedestrian refuge will stay in situ? It should.

6 There ought to be yellow hatching on the Banbury Road at the southern Bridge End entrance to make it easier for cars to exit Bridge End when the traffic is busy on the Banbury Road.

7 Can you reassure me that traffic going towards Warwick will be controlled at this junction? In other words there

doesn't appear to be any reason to stop this traffic at a red light at all? What assurances can you give that this traffic will have to stop at the traffic lights? Again pedestrian safety is the major concern.

8 There needs to be clear signage preventing cars from turning right out of the school—as vehicles do at the moment despite clear signage to the contrary.

9 The school should provide marshalls at least initially to prevent parents from using Bridge End as an unofficial drop off point.

10 Can you confirm when the works will be undertaken? Presumably during the summer holidays.

11 Finally the 20 mph speed limit should be extended out all the way to the Gallows Hill traffic lights. There is very widespread and flagrant abuse of the speed limit on this section of Banbury Road which is particularly alarming given the fact it is outside a school entrance !!

I write to raise my concerns with regards to parents and children of the Warwick School Foundation using Bridge End as a drop off and collection point in preference to entering into the school traffic system. Also of sixth formers who park in Bridge End rather than in the school sixth form area to either avoid this cost, or perhaps there are not enough allocated places.

This already happens on a daily basis and at 4pm there is a queue of cars parked on the double yellow lines on the south entrance to Bridge End. In the mornings many people use this space as a drop-off point, and even drive right across the entrance which is most inconsiderate and prevents anyone turning left or right on to the Banbury Road at all.

Where the double yellow lines finish on the south side of Bridge End it is a regular occurrence that people from the Warwick Technology Park leave there cars here all day. This is not a smart move as if they park in the road there is then not enough room for a delivery or dustbin lorry to pass on the road. The vehicle has to then drive on the grass verges on the front of our gardens which trashes the grass and regularly knocks out the cobbles. The existing double yellow lines don't currently stop the road being used as a drop-off and pick-up area, but they do stop people leaving their vehicles all day.

With the changes to Warwick school and their new entrance nearing completion this summer the impact this could have on Bridge End residents needs to be considered.

It would be a good idea for the school to employ traffic marshalls now as well as when the new campus opens so that they can address an already existing problem and take this into account in their communication to parents and their future planning.

Perhaps the idea of introducing residents and visitor permits within Bridge End would mean that it could no longer be used as a general place to park all day.

The new proposed traffic light system going into the school campus sounds like a good idea but I have a concern that turning right out of the south entrance of Bridge End may become impossible at times. During the existing building works there have been occasions that the traffic turning left off the Banbury Road into the Warwick Prep entrance has backed up so much that I have been stuck and unable to turn right for a considerable time.

I hope that this feedback is useful and that due consideration can be given the the matter to alleviate what could be problems in the future.

I object to the proposed traffic signal as currently planned for the following reasons:

1. The route into the school from Bridge End will be made more dangerous for pedestrians (mainly children) crossing the road by the proposed traffic lights. At present people cross using the existing island when there is a gap in the traffic. The proposed lights on one side of the road means that pedestrians will be crossing in front of vehicles stopped by the lights and therefore need to be more aware of when the lights are about to change.

2. Pedestrians will need to know to look for vehicles travelling into Warwick but also for cars turning right out of the school exit. I'm aware that this will not be permitted, as it isn't now, but that doesn't stop drivers doing so. Both exits from Warwick School have signage stating left turn only, but I often see this ignored.

I believe the only way to make the proposed crossing safe is to install a controlled crossing. Please can you consider this when making the final decision on the plans.


Many thanks for your clarification. In that case I will certainly be opposing the scheme.

Thank you for the opportunity to comment on the proposals. They are as follows:-

1. The new developments south of Warwick will bring even more congestion to the Banbury Road and residents of Bridge End are not convinced of the practicality and achievability of the current plans for the town centre and the Banbury Road area. The Save Warwick Group employed a consultant transport planner during the appeal against the Asps development three years ago. The analyses undertaken by his company at the time predicted the likelihood of grid lock at peak periods in the centre of Warwick in spite of the improvements that were proposed in the town centre.

As a result of the planning consents granted for more housing developments to the south of Warwick since then this situation is sure to get even worse, particularly on the Banbury Road and it is vital for the welfare and safety of residents and visitors to this part of Warwick that an overall traffic management plan should be produced and implemented for this area in consultation with the local community.

2. A pelican type crossing would allow safer crossing of the Banbury Road for schoolchildren. I am aware of and agree with the feedback you are receiving from other residents and consultees that a pelican crossing

should be constructed across the Banbury Road as part of the plan currently under consultation.

3. It is equally important, however, as part and parcel of these proposals that consideration be given to the management of traffic in the area between here and Warwick Town Centre which will be used by an increasing number of schoolchildren as a result of the new school development.

No doubt the County Council is still keen to reduce the numbers of vehicles on the roads in Warwick - and at peak periods the roads around the south are clogged by cars delivering or collecting children to/from school. The absence of a controlled crossing across the Banbury Road in the current plan does not provide any evidence that plans are being made to make the hostile environment for children walking or cycling to school any safer for them. It has to be a fact that while parents feel their children are unsafe on the roads they will not allow them to walk or cycle to school so, surely, achieving this and the consequent reduction in road traffic should be part of the plan under consideration. Indeed the current plan is simply intended to make it easier for even more cars to use the roads for access to the school.

4. Finally, it has to be said that whatever applies to children, also applies to older people. The residents of the 150 odd houses in the Bridge End are finding it increasingly difficult to cross the Banbury Road safely and though the construction of this light controlled crossing to give access to the school will assist local parents and their children it is not a solution to the problem for the rest of us. A comprehensive management plan for traffic and pedestrians needs to be developed and implemented for the area which will allow us all to use the roads and pavements safely and comfortably.

Friday 1st March is the deadline for any objections to the proposed new entrance to Warwick School in Banbury Road arising from the relocation Kings High School, Warwick to the Warwick Boys School campus.

We understand that the principle of moving the school entrance further along the Banbury Road was approved as part of the Warwick School planning application and note:

• that the proposed traffic signal junction makes provision for an uncontrolled crossing rather than a controlled pedestrian crossing linked to the traffic lights and consider such a proposal is negligent given: that some 700

extra pupils will be accessing the campus from September of this year. We share concerns of those of our neighbours with youngsters attending these schools who really ought to cross the road by way of a controlled pedestrian crossing.

- We request that a controlled pedestrian crossing be installed at the new entrance to the school campus on the Banbury Road to alleviate fears and potential loss of life on what is already an exceptionally busy road.
- We also request that consideration be given to extending the 20 mile speed limit over the River Bridge and onto the section of the Banbury Road to the new entrance to the school campus.

The volume of traffic in and around Bridge End will greatly increase from September of this year - there appears to have been little consideration given to this.

- Some pupils attending local schools are regularly dropped off in Bridge End directly behind our garden in the section of the road with double yellow lines. This unofficial drop off/collection point needs to be firmly discouraged for it provides the potential for a traffic accident.
- Likewise there should be no unofficial drop off points at the South entrance to Bridge End which is already clearly marked with double yellow lines and no parking signs.

We understand that there are proposals to replace the roundabout at the Myton Road/ Banbury Road Junction nearest the River Bridge with traffic lights and trust that these proposals which we have yet to see in detail, will include sufficient pedestrian crossings linked to traffic lights.
