Decision taken

I, as Cabinet Portfolio holder for Community Safety, agree to the use of the Fire Capital Grant received from DCLG in 2011/12 for the purposes set out in the report and as appended to this notice.

Reasons for Decisions

Warwickshire Fire and Rescue Authority received £989,808 Capital Funding Grant. The grant is already in the Fire and Rescue Capital Programme and the reasons for the choice of allocation of the grant are set out in the report and given in the appendix to this decision.

Background Information/ factors considered in arriving at these decisions - (set out below or attach officer report):

Background

- 1.1 Through the Spending Review, £70m capital grant funding was allocated to Fire and Rescue Authorities in England for 2011/12.
- 1.2 Using a pro-rata distribution, Warwickshire Fire and Rescue Authority received £989,808 as set out in the Fire and Rescue Authorities Capital Funding Grant Determination 2011/12 (No. 31/1867). The grant conditions state that the grant may be used "only for the purposes that a capital receipt may be used for in accordance with the regulations under section 11 of the Local Government Act 2003." This means that the grant can be spent on any type of capital expenditure.
- 1.3 Council agreed the use of the grant by Fire and Rescue on the 29th March 2011 following consideration of the 2011/12 Service Estimates Report and therefore the grant is already within the Fire and Rescue capital programme.

2.0 Use of the Fire Capital Grant 2011/12.

2.1 The use of the grant relates mainly to improvements across a number of fire stations which will address health and safety, training / operational fitness and community access issues. In addition some of the grant will be used to purchase new specialist equipment and a new system for managing and tracking all equipment across the service to improve efficiency and effectiveness.

Financial and Legal Implications

Once the capital programme is agreed by the Portfolio Holder Community Safety, most of the schemes will start immediately and the intention is that the whole programme will be completed by March 2013.
