National Demonstrator Programme For Common Assessment Framework (CAF)

Warwickshire County Council and NHS Warwickshire Partnership bid for £5M investment from Department of Health to fund years 2 and 3 of the local CAF programme

Report of the Strategic Director of Adult, Health and Community Services

Recommendation

That the Portfolio Holder Adult Social Care approves the submission of a formal bid to the Department of Health for £5M funding to enable our local Common Assessment Framework partnership to continue development and evaluation work for a further two years.

1. Background

- 1.1 Following Warwickshire's selection by the Department of Health to participate as one of 9 authorities in phase1 of the national Common Assessment Framework (CAF) programme, work has been underway since February 09.
- 1.2 The Warwickshire CAF proposals are underpinned by an alignment of the County Council's and PCT's respective strategic plans, demonstrating a synergy in direction of travel, transformational agendas and priorities. *A Healthy future for Warwickshire* and its associated Warwickshire Integrated Improvement Programme mirrors the County Councils Social Care Transformation programme *Creating a Vision & Turning Vision into Action* with its associated focus on self assessment and brokerage; customer satisfaction; self directed care and personal budgets, living at home. The two agencies' priorities for 2008-12 are similarly aligned, targeting long term conditions, reducing health inequalities, well informed public and greater personal independence, choice and control.
- 1.3 Both organisations also have an interest in developing innovative technical solutions that are based on internet technology to enable the customer to retain ownership of their information and for customers to drive governance arrangements that allow information to be shared across the multiple agencies providing support in the community.



- 1.4 The Warwickshire CAF project has received a mix of capital and revenue funding, totalling £2.135M during 2009/10 to support the development, testing and evaluation of new systems to enable effective information sharing between health and social services. It is also recognised to be both high innovation and as such, high risk.
- 1.5 Department of Health (DH) colleagues have mitigated against this risk by requiring an additional qualification stage for Warwickshire to apply for funding for the full three year programme after year one.
- 1.6 The second round of selection for national funding has commenced during November 2009, with the outcome of the selection to be published in January 2010. DH have classified Warwickshire as already being short listed for this selection process and are working closely with the project board to ensure the second round bid is successful.

2. Progress to date

2.1 Key Project Deliverables for Year 1

- 2.1.1 Primarily, year 1 of the Warwickshire CAF programme is delivering prototype systems to enable AHCS and NHS Warwickshire to work together more seamlessly in a community setting. The systems are centred on the customer and enable both social care and health staff to provide support through self-assessment, support planning and service delivery with the customer having the opportunity to control / manage their 'story', as an electronic record.
- 2.1.2 Three initial sites, where joint working across AHCS and NHS Warwickshire is being enhanced by CAF are:
 - Site A: Virtual Ward at Learnington;
 - Site B: Rugby Older People Physical Disabilities team and Community Matrons
 - > Site C: Alcester Health and Social Care Integrated team.

2.2 Position statement against key deliverables

- 2.2.1 The project has delivered the prototype software to sites A and B in October, having completed high level business process analysis and agreed improved processes across health and social care for these sites. Staff and customers are becoming engaged in the project and being empowered to influence the design of the system.
- 2.2.2 Plans are: to implement the system in site C, the Alcester Integrated Team in January 10.



- 2.2.3 A formal 6 month review has been undertaken with the DH team and feedback on Warwickshire's progress has been very good, with DH colleagues commenting that Warwickshire is the only CAF demonstration site to have delivered their prototype system during year 1 of the programme.
- 2.4.4 The timetable for year two and three funding bids (second round) has been agreed with DH and they are actively participating in local workshops during later part of October and November 09 to ensure our Warwickshire submission includes all required information to enable the second round bid to be successful.

3. Next Steps

- 3.1 The Warwickshire Year 2 and 3 bid must be submitted to DH on 26 November.
- 3.2 As the bid is already short-listed. DH will be considering the Warwickshire bid alongside all other short-listed submissions during December and will formally publish their decision on the final selection in January 2010.
