Increases in Charges for Licences to Work within the Highway and Authorisations for Multi Phase Temporary Traffic Signals

Report of the Strategic Director for Environment and Economy

Recommendation

That the increases in charges for Licences to work within the highway, the authorisation of multiphase temporary signals within the highway and switching off/on existing traffic signal junctions or pedestrian crossings, identified in this report are approved and implemented with immediate effect.

1. Introduction

- 1.1 Only persons with the correct statutory powers or an authorised licence can carry out work within the public highway. Warwickshire County Council authorises a private individual or companies by issuing an applicable licence, for which a charge is levied.
- 1.2 Charges are also made to third parties for:-
 - (i) the authorisation of multiphase temporary signals within the highway, and
 - (ii) switching off/on existing traffic signal junctions or pedestrian crossings for private individual or companies.
- 1.3 Fee levels for investigatory inspections under The Streetworks Inspection Fees Regulations were raised by the Department for Transport (DfT) from £25 to £50 this year. These increased charges are automatically applied to those works carried by Utilities under their statutory powers.
- 1.4 It is now proposed to apply the increased fee level determined by The Streetworks Inspection Fees Regulations to all works carried out within the highway. At the same time the opportunity has been taken to carry out a general review of charges.



2. Licences/Authorisations – Current Arrangements

2.1 The current level of fees for the licences and authorisations are as follows:-

Section 50	For installing new apparatus For maintenance of existing apparatus	£527 £265

3. Licences/Authorisations – Proposed Arrangements

3.1 For licences under Section 50 of NRSWA it is proposed that the licence fees be increased to reflect the increases in fees by the DfT for inspections. As each licence allows for three inspections and each inspection has increased by £25, this will increase the licences by £75.

Therefore the licence fees proposed are as follows:-

For maintenance of existing apparatus $\pounds 265 + \pounds 75 = \pounds 340$

3.2 Section 171 covers excavation in the highway and/or depositing/storing materials or other things on the highway.

The current level of charge does not adequately cover the administrative work carried out. It takes on average two and half hours to process a licence, including phone calls, issuing of the licence and processing all necessary payments. The charge would allow for at least one visit to the site with the applicant to agree, a suitable location, working method and temporary traffic management. The administrative cost is estimated to be £100 inclusive of all overheads.

Three inspections are necessary during the licence period, to ensure compliance with conditions, on completion of final reinstatements and/or to ensure all remedial works are carried out and at the end of a two year guarantee period. It



is proposed to apply the nationally agreed inspection charges set by the DfT for these licences.

Therefore the new Section 171 licence fee proposed is as follows:-

Administration	£ 100
Inspections	3 x £50 = £ 150
Total	£ 250

- 3.3 It is proposed to increase the fees for the works associated with the authorisation of multiphase temporary signals by £25, this reflects the increase in operational costs in providing this service.
- 3.4 Warwickshire Traffic Signal Contractor has increased its fees associated with switching the existing traffic signal junctions or controlled crossings off/on on behalf of the authority, the increased costs need to be passed on to the individual or companies who have requested for this work. The increases are as follows:-

During office hours (per site visit)£45Outside office hours (per site visit)£50.

4. Summary

4.1 The review has identified a number of increases in fee for operations carried out by a third party in the highway.

These are as follows:-

5. Financial Implications

5.1 The increase in charges will accurately reflect the cost of work carried out and increase the income to cover these costs. On average in a year, there are 100 Section 50 Licences issued and 50 Section 171's, this would therefore increase income by £15,000. Also on average there are 140 application for multiphase temporary signals 25 of which will requires the permanent signals to be switched off and on. This would increase income for work associated with multiphase temporary signals by £5,000.
