Warwick District Council Off-Street Parking Places Order 2012

Recommendation

That the Portfolio Holder consents to Warwick District Council's proposal to make the Warwick District Council Off-Street Parking Places Order 2012.

1.0 Key Issues

- 1.1 Warwick District Council (WDC) has requested that charges for on and off-street short stay parking in Leamington be unified.
- 1.2. At the Portfolio Holder Transport and Highways Decision Making Session on 24 April 2012 it was agreed that a linear on-street parking charge be introduced in pay and display streets in Leamington Spa based on 50p for half an hour but with a 20p minimum payment for 12 minutes.
- 1.3. The County Council has now been consulted on WDC's proposals for the corresponding changes in its off-street car parks in Leamington.

2.0 Proposals

- 2.1 WDC's proposals are included as **Appendix A**. The proposals will achieve unity between on and off-street short stay parking charges in Leamington.

3.0 Timescales associated with the decision/Next steps

- 3.1 It is anticipated that the changes to both on and off-street parking charges will be introduced in July 2012.

Proposed Off-Street Parking Charges

1 Leamington Car Parks – Short Stay

Bedford Street, Chandos Street and Covent Garden Surface

Remove existing tariffs between 8am and 8pm	Charge
To introduce new tariffs as follows;	
A minimum stay of 12 minutes	£0.20
A linear charge * set at 6 minute intervals between the minimum and maximum stay	£0.10
A maximum stay of 4 hours	£4.00
Charges between 8pm and 8am remain unchanged.	-

2 Leamington Car Parks – Long Stay

Rosefield Street and Adelaide Road

Remove existing tariffs between 8am and 6pm	Charge
To introduce new tariffs as follows;	
A minimum stay of 12 minutes	£0.20
A linear charge set at 6 minute intervals between the minimum stay and the 4 hours and over tariff	£0.10
4 hours and over	£4.00
Charges between 6pm and 8am remain unchanged.	

3 Leamington Old Town Car Parks – Long Stay

Bath Place, Packington Place and Court Street

Remove existing tariffs between 8am and 6pm	Charge
To introduce new tariffs as follows;	
A minimum stay of 24 minutes	£0.20
A linear charge set at 12 minute intervals between the minimum stay and the 6 hours and over tariff	£0.10
6 hours and over	£3.00
Charges between 6pm and 8am remain unchanged.	

4 Leamington Pay on Foot Car Parks

(a) St Peters MSCP

Remove existing tariffs between 8am and 8pm	
To introduce new tariffs as follows;	Charge
A minimum stay of 12 minutes	£0.20
A linear charge set at 6 minute intervals between the minimum stay and the 4 hours and over tariff	£0.10
4 hours and over	£4.00
Charges between 8pm and 8am remain unchanged.	

(b) Covent Garden MSCP

Remove existing tariffs between any 24 hour period	
To introduce new tariffs as follows;	Charge
A minimum stay of 12 minutes	£0.20
A linear charge set at 6 minute intervals between the minimum stay and the 3 hours and over tariff	£0.10
3 hours and over	£3.00

* "Linear charge" means progressing from one charge to another in a series of incremental time steps.
