Decision Taken

- 1. That £1,025,172 of ring-fenced DfE grant for the introduction of Universal Infant Free School Meals is added to the capital programme.
- 2. That £47,828 of previously approved resources from Physical Assets Capital Maintenance Programmes are allocated to support the provision of Universal Infant Free School Meals.
- 3. That a programme of works totalling £1,073,000 is carried out to implement this programme.

Reasons for Decisions

In December 2013 DfE announced an allocation of grant funding to support the rollout of Universal Infant Free School Meals (UIFSM).

The Funding was made available from April 2014 and the entitlement to UIFSM's must be achieved by September 2014.

Resources Group has polled all of the eligible schools and assembled a picture of needs. In accordance with WCC corporate policy it is necessary to add the UIFSM funding to the capital programme before expenditure is incurred.

Financial Implications

Local authorities are encouraged to consider how they might use their school maintenance and improvement budgets to support the delivery of universal infant free school meals. The funding gap between DfE grant and the proposed programme is £47,828. It is proposed to add the grant of £1,025,172 to the Physical Assets Capital Programme and to allocate £47,828 from maintenance funding to support the UIFSM programme.
