Resolved:

- (4) That the Committee appoints Councillors David Booth and Frank McCarney to the Joint Negotiating Body for Staff (*two members of Cabinet – Councillors Alan Cockburn and Bob Stevens were appointed by the Cabinet on 17 May 2005.*)
- (5) That the Committee appoints Councillors Richard Grant and John Whitehouse to the Joint Negotiating Body for non-teaching staff (*two members of Cabinet – Councillors John Burton and Peter Fowler were appointed by the Cabinet on 17 May 2005.*)
- (6) That the Committee establishes the following sub-committees:
- (a) School Governing Bodies Sub-Committee to review the overall distribution of places of school governing bodies between the political groups and independent members of the Council. The membership to be 5 councillors (two nominated by the Conservative Group, two nominated by the Labour Group and one nominated by the Liberal Democrat Group).
  - (b) Outside Bodies Sub-Committee to review the overall distribution of places on external bodies (excluding school governing bodies) between the political groups and independent members on the Council. The membership to be 5 councillors (two nominated by the Conservative Group, two nominated by the Labour Group and one nominated by the Liberal Democrat Group).
- (7) That the Sub-Committees report to a future meeting of the Committee with proposals for appointments to the bodies for which it is responsible.
- (8) That the Committee confirms the delegation of local choice and non-executive functions made by the Regulatory Committee of the previous Council to Area Committees and officers.
