That the Regulatory Committee authorises the grant of planning permission for the retention of a temporary classroom for the use of the Before and After School Club, at St Paul's C of E Primary School, Wiclif Way, Nuneaton, subject to conditions and for the reasons contained in **Appendix B** of the report of the Director of Planning, Transport and Economic Strategy.

## 1. Application Details

- 1.1 The planning application proposes the variation of condition no.4 of planning permission N26/04CC045 for the retention of one temporary classroom, no.213 for the use of the Before and After School Club at Wiclif Way, Nuneaton. This will be located at the North East corner of the playground, near Wiclif Way.
- 1.2 The proposed retention of the temporary classroom is to accommodate the before and after school club that provides childcare for children attending the school between the ages of 4-11 in school term time. The club operates before the hours of 7:30am and 8:55am and after school between 3.15pm and 5:30pm. There are approximately 40 children on the books of the club and there are usually between 3 and 4 members of staff supervising.

#### 2. Consultations

- 2.1 Nuneaton and Bedworth Borough Council— No objections.
- 2.2 **Councillor M J Jones –** No comments received.
- 2.3 **County Museum –** Ecological response no objection.
- 2.4 **County Museum -** Archaeological comment no objection.

#### 3. Observations

#### Site and Surrounding Area

- 3.1 The application site is located within a residential area of Stockingford, in the town of Nuneaton. To the North and East of the site are houses, to the South and West open grassland areas.
- 3.2 The temporary classroom is located to the North East of the school site, in the top right hand corner of the school playground, closest to Wiclif Way. This corner is partially screened by trees.
- 3.3 Planning permission has been granted for the construction of a single storey classroom block extension, incorporating four classrooms, two practical rooms, a group room and toilet facilities. This included condition 4 requiring that: 'Within three months of first occupying the development hereby approved, the 4 temporary classrooms shall be removed from site'. The applicants are asking for a variation on this condition to allow for the retention of this temporary classroom in its current location.

#### **Planning Policy**

3.4 Policy ER1 of the Warwickshire Structure Plan sets out policies in relation to natural and cultural environmental resources and the protection of the environmental assets of the county. Policy ER2 of the Structure Plan sets out policies in relation to the environmental impact of development on the landscape

- and material assets of the county. The proposal would not have a detrimental impact on the local landscape and therefore accords with these policies.
- 3.5 Policy Env13 of the Nuneaton and Bedworth Modifications 2005 states the design and material of all development should be of a high standard in keeping with the scale and character of the locality.

#### **Visual Impact**

- 3.6 The application site is located within a residential area with the applicant proposing to retain one existing temporary classroom located in the top right hand (North East) corner of the playground, closest to Wiclif Way. Where the proposed classroom is situated, there are relatively mature trees around the corner of the site, approximately 4-5 metres in height that help to partially screen the classrooms from the road and overlooking residential properties. Visual impact would, in fact, be lessened due to the removal of the other three temporary classrooms. It is therefore considered that the proposal would have an acceptable visual impact upon the locality.
- 3.7 In addition the retention of the classroom building will have only a limited impact upon the amenities enjoyed by local residents occupying nearby properties.

#### 4. Conclusion

4.1 The proposed retention of a temporary classroom to the North East of the playground of St Paul's C of E Primary School, Nuneaton, is considered to be acceptable when taking into account all material considerations relating to the development.

## 5. Environmental Implications


5.1 The size and scale of the proposed development would have only a limited impact on the visual amenities of the locality.
