4. Applications for Determination

Reports of the Strategic Director for Environment and Economy.

(1) Bubbenhall Landfill Site – Amendment to Profile and Restoration of Landfill

The application seeks planning permission to vary the profile of the site to ensure adequate post-settlement gradients are achieved to promote surface water drainage across the site and to alter the restoration scheme at Bubbenhall Landfill Site, Western Lane, Bubbenhall.

At the 2nd May 2006 meeting of the Regulatory Committee Members resolved to make a site visit to Bubbenhall Landfill prior to determining the application. A site visit is scheduled to take place on 8th June 2006.

Recommendation

That the Regulatory Committee authorises the grant of planning permission to vary the profile of the site to ensure adequate post-settlement gradients are achieved to promote surface water drainage across the site; and to alter the restoration scheme at Bubbenhall Landfill Site, Western Lane, Bubbenhall, subject to the conditions and for the reasons contained in Appendix B of the report of the Strategic Director for Environment and Economy.

(2) Construction of a 45 Metre Diameter Roundabout at the Potford's Dam Junction of the A4071 and the Approved Rugby Western Relief Road

The provision of a 45 metre diameter Roundabout at the Potford's Dam Junction of the A4071 and the approved Rugby Western Relief Road. This would replace the ghost island junction forming part of the previously approved scheme for the Rugby Western Relief Road granted planning permission under local authority reference no. R1442/02CC093.

Recommendation

That the Regulatory Committee authorises the grant of planning permission for the construction of a 45 metre diameter roundabout at the Potford's dam junction of the A4071 and the approved Rugby Western Relief Road, Rugby, Warwickshire, subject to the conditions and for the reasons contained in Appendix B of the report of the Strategic Director for Environment and Economy.



(3) Ettington C of E Primary School – Construction of an Extension to the Main Building to Create a Classroom, Library and Associated Facilities

The application is for the construction of an extension to the main building to create a classroom, library and provide associated facilities at Ettington Church of England Primary School, Church Close, Ettington.

Recommendation

That the Regulatory Committee authorises the grant of planning permission for the construction of an extension to the main building to create a classroom, library and associated facilities at Ettington Church of England Primary School, Churchill Close, Ettington, subject to the conditions and for the reasons contained in Appendix B of the report of the Strategic Director for Environment and Economy.

(4) Former Leyland School, Nuneaton – The Erection of 2.4 Metre High Triple Spiked Palisade Fencing to be Powder Coated Green, Incorporating Vehicular Access Gates to the Western Site Boundary

This application is for the erection of 2.4 metre high triple spiked palisade security fencing to be powder coated green, incorporating vehicular access gates to the western site boundary of the former Leyland School, Leyland Road, Nuneaton.

Recommendation

That the Regulatory Committee authorises the grant of planning permission for the erection of a 2.4 metre high triple spiked palisade fencing to be a powder coated green, incorporating vehicular access gates to the western site boundary at the former Leyland School, Leyland Road, Nuneaton, subject to the conditions and for the reasons contained in Appendix B of the report of the Strategic Director for Environment and Economy.

(5) All Saints C of E Junior School, Warwick – Erection of Security Fencing and Access Gates

This application is for the replacement of timber fencing with 2m high metal bar fencing on the eastern site boundary and replacement of existing fencing and access gates at access points on southern and northern boundaries to the same specification. Also the erection of 2m high triple pointed topped palisade fencing to a section of the southern boundary and 1.2m high triple pointed palisade fencing on the top of sections of the northern boundary wall and garages at All Saints C of E Junior School, Warwick.

Recommendation

That the Regulatory Committee authorises the grant of planning permission for the siting of three sections of 2 metre high metal bar fence, one section of 1.2 metre high palisade fencing and one section of 2 metre high palisade fencing at All Saints C of E Junior School, Nelson Avenue, Warwick, subject to the conditions and for the reasons contained in Appendix B of the report of the Strategic Director for Environment and Economy.



(6) Newburgh Primary School, Warwick – Erection of 2.4 metre high steel weld mesh
