All Saints C of E Junior School, Warwick - Erection of Security Fencing and Access Gates

Report of the Strategic Director for Environment and Economy

Recommendation

That the Regulatory Committee authorises the grant of planning permission for the siting of three sections of 2 metre high metal bar fence, one section of 1.2 metre high palisade fencing and one section of 2 metre high palisade fencing at All Saints C of E Junior School, Nelson Avenue, Warwick, subject to the conditions and for the reasons contained in **Appendix B** of the report of the Strategic Director for Environment and Economy.

THE PROPOSAL:	Replacement of timber fencing with 2 metre high metal bar fencing on the eastern site boundary and replacement of existing fencing and access gates at access points on southern and northern boundaries to the same specification. Also the erection of 2 metre high triple pointed topped palisade fencing to a section of the southern boundary and 1.2 metre high triple pointed palisade fencing on the top of sections of the northern boundary wall and garages.
SITE AND LOCATION:	All Saints C of E Junior School, Nelson Avenue, Warwick.

1. Application Details

1.1 The application proposes the erection of six sections of security fencing around the school boundary. Three of the sections within the scheme would replace existing timber fencing and access gates with 2 metre high metal bar fencing at the main entrance to the school an at two other access points. One section of 2 metre high metal bar fencing replacing and existing timber fencing which marks the boundary between the School and Avon Court Old People's Home. The application also proposes the erection of a section of 2 metre high triple pointed palisade fencing, coloured green, alongside the garages to the south of the site and the erection of 1.2 metre high triple pointed topped palisade fencing to top boundary brick wall and garages to the north of the site.

2. Consultations

- 2.1 **Warwick District Council** No objection.
- 2.2 Warwick Town Council No comments received.
- 2.3 **Councillor K Browne** I support this application as a measure to reduce damage to the school and littering and other abuse to the school grounds. However, I hope the school will continue to allow local groups and local children to use the playing fields for legitimate leisure purposes.
- 2.4 **Councillor Mrs M Haywood** I support this application as a measure for reducing vandalism on the site.
- 2.5 **County Museum** Recommendation that the applicant is made aware that "Work should avoid disturbance to nesting birds. Birds can nest in many places including buildings trees, shrubs, dense ivy and bramble/rose scrub. Nesting birds are protected under the 1981 Wildlife and Countryside Act and the Countryside and Rights of Way Act 2000. The main nesting season lasts approximately from March to September, so work should take place outside these dates if at all possible. N.B. birds can nest at any time, and the site should ideally be checked for their presence immediately before work starts."
- 2.6 **Police Architectural Liaison Officer** No comments received.

3. Representations

- 3.1 4 letters from local residents regarding:-
 - (i) Visual impact on the locality, with the fence not being in keeping with the surroundings.
 - (ii) The "fortress like environment" that would be created.
 - (iii) Concern that the fence would not address the security problem as the existing lower fence will remain at other points around the school boundary; in particular through the allotment area in Dale Close and the



lane running parallel to Dale Close and Montague Road behind properties. In addition to this there is concern that entry may also be gained over garage roofs, through residents gardens and via the grounds of Old-People's Home.

(iv) The fence would be ineffective in deterring entry to the site and other methods should be considered.

4. Observations

Site and Surroundings

4.1 The site is predominantly surrounded by residential properties, abutting rear gardens along the majority of its boundary. Sections of the site boundary back on to garages and to the south a section of the boundary adjoins an area of allotments, which are accessible via a pedestrian lane running parallel to Dale Close and Montague Road behind properties. To the south the site boundary adjoins Avon Court Old People's Home. The site boundary is currently bounded by a wooden fence which is, in places, in poor condition.

Visual Amenity

4.2 Concern has been raised by local residents that the proposed fencing would have a detrimental effect on the outlook from their property, however, the fence will be replacing an existing fence.

Crime

4.3 Increased security of the site has been sited as a reason for the application, and crime on the site has been highlighted as a problem by residents in the responses received. It is considered that the proposed security fencing would reduce the ease of access to the site at a number of points, with the open design of the fencing still allowing for natural surveillance of the site.

5. Policy

- 5.1 Policy DP13 of the Warwick District Local Plan promotes the layout and design of development that "minimise the potential for crime and anti-social behaviour and improve community safety" and to secure crime prevention through the provision of an appropriate security measure. The proposed fencing therefore accords with this policy.
- 5.2 Policy DP2 of the Warwick District Local Plan (1996-2011 Revised Deposit version may 2005) states that development which has "an unacceptable adverse impact on the amenity of nearby uses and residents" will not be permitted. Examples include "loss of outlook" and "visual intrusion". Although the proposed fencing will have a slight impact on the usual appearance of the area this is outweighed by the need to secure the school from trespass.



6. Conclusions

6.1 The proposals would improve security at the school and would not have an unacceptable adverse impact on the amenity of the locality. The need to secure the school from trespass is of sufficient weight to justify the grant of planning permission despite the slight impact on the amenity of the area due to the appearance of the fence.

7. Environmental Implications

7.1 The size and scale of the proposed development would have only a limited impact on the visual amenities of the locality. There are no significant environmental considerations associated with the proposed development.
