That the Regulatory Committee authorises the grant of planning permission for the erection of the proposed 2 metre high security fence and access gates at Oakfield Junior School, Southlands, Atherstone, subject to the conditions and for the reasons contained in **Appendix B** of the report of the Strategic Director for Environment and Economy.

The Proposal: The erection of a 2 metre high triple splayed top palisade

fence and access gates on a section of the eastern site

boundary.

Site and Location: 2.9 hectares of land at Oakfield Junior School, Southlands,

Atherstone, CV9 1EH (grid ref: 431047, 297304).

See plan in Appendix A.

1. Application Details

1.1 The proposed development is for the erection of a 2 metre high triple spiked palisade security fence and gates to be located on a section of the eastern boundary of the school. It is proposed that the fence will replace the existing 1 metre high wooden post and rail fence and will secure areas of the site which are currently easily breached.



1.2 It is proposed that the fence will be coloured green and run for a distance of 32 metres. The fence is to be located on the boundary segregating the school site and residential close of Bath Road.



3. Representations

3.1 Three letters of representation have been received from local residents. The letters of representation raise concerns relating to the extent of the fence, and that the location of the fence will leave the neighbouring properties vulnerable to trespassers looking for alternative routes out of the school.

4. Observations

- 4.1 Oakfield Junior School is located within a residential area to the south of Atherstone. The site, the subject of this application is currently occupied by a Junior School and associated playing fields. The main vehicular and pedestrian access to the school is located off Southlands, however a secondary pedestrian and vehicular access (emergency access) is located off Bath Road.
- 4.2 The site is currently partially secured by a 2 metre high palisade fence. The proposed fence is to be sited in order to further secure the site and to prevent free movement through the site out of school opening times. The school currently suffers from unauthorised trespass and damage to the school buildings.
- 4.3 The location and extent of the proposed fence has caused concern to local residents living adjacent to the site. The fence is proposed to be sited on an area currently secured with a 1 metre high post and rail fence which runs along the end of the Cul-de-sac, between properties 11 and 8 Bath Road. The residents, although not objecting to the principle of having the fence, are concerned that the fence will encourage unauthorised access through their properties from people trying to get out of the school. Discussions have been held with the school, however the school do not propose to extend the fence.



- 4.4 It is considered that the implementation of the fencing will provide additional security to the school and should deter unauthorised access along this boundary. Local residents have raised concern relating to the location and extent of the proposed fence, which they feel leaves them potentially vulnerable to trespass.
- 4.5 The impact of the development and potential issues relating to crime in the locality is a material consideration to be taken into account, and negotiations with the school have taken place to try and address the objections. Following the discussions, the school has agreed to extend the fence by approximately three metres along the boundary with number 11 Bath Road, joining to an existing high fence, however the school do not propose to install any additional fencing to that proposed in the application along the boundary with number 8 Bath Road.
- 4.6 The garden at Number 8 Bath Road is fully enclosed with 4ft high wooden fencing along the boundary with the school, the bungalow, garage and locked gate forming a boundary fronting Bath Road and residential fencing to the remaining boundaries. It is therefore considered that it would be a fairly difficult path to take out of the school grounds, however it is possible that should someone wish to trespass this route could be used.
- 4.7 The overall security at the school site will be improved, and on balance it is considered that the route through the adjacent property would not be seen as an easy route into or out of the school. It is therefore not considered appropriate to refuse the application based on the objections received from local residents.
- 4.8 It is not considered that the proposed development will have an unacceptable adverse impact on the amenity of the locality as a whole.

5. Planning Policies

5.1 The proposed development accords with Policy ENV14 of the North Warwickshire Local Plan First Deposit Draft – February 2003. This policy considers that development should be designed and laid out to reduce opportunities for crime.

6. Conclusions

6.1 The proposed development is considered to be acceptable with development plan policies and would not have an unacceptable adverse impact on the amenity of the locality as a whole. There is an acknowledged need to secure the school from trespass and the objections to the proposal are not of sufficient weight to justify the refusal of planning permission.


7. Environmental Considerations
