# **Report of the Strategic Director, Resources**

#### Recommendation

It is recommended that the Committee:

• Consider the proposals for public consultation on the 2009/10 Budget and Council Tax.

### 1 Introduction

1.1 The budget is a statement, in financial terms, of the authority's plans for the financial year. As such the authority has considered it best practice to seek the priorities and views of all stakeholders in its preparation. This is done throughout the year as part of our corporate consultation process.

## 2 Proposals for 2009/10 Budget Consultation

2.1 The report to the Resources, Performance and Development Overview and Scrutiny Committee in June last year proposed to limit future consultation to the use of the Citizens Panel with an option to present to the Area Committees. This was approved by Cabinet at their 19 July 2007 meeting. This process was completed last year with a response rate of over 50% for the Citizens Panel survey and the results were presented to Cabinet in January 2008. There are no plans to change the process for 2009/10.

#### 3 Results

- 3.1 In order for the information to be presented to members in time for them to take account of the views from the consultation in the budget setting process it is proposed that the results and analysis from the 2009/10 budget public consultation process will be presented for consideration at Cabinet on 8<sup>th</sup> January 2009.
- 3.2 The date of the Resources, Performance and Development Overview and Scrutiny Committee before the 8<sup>th</sup> January Cabinet is 11<sup>th</sup> November 2008. This means that the results of the consultation process will not be available to this Committee until after they have been reported to Cabinet in January 2009.
