2. Proposed Closure of Bishop Wulstan Catholic School, Rugby

The report of the Strategic Director for Children, Young People and Families was considered.

Mark Gore introduced the report and paid tribute to the work of the school and in particular to the leadership of the Head and the Chair of Governors. He then went onto to highlight the key issues in the report.

The Chair then invited Eddie Keeley, Chair of Governors, Brendan Higgins, Head and Father Marcus Stock, Director of Schools, Archdiocese of Birmingham to speak on behalf of the school.

The Chair then stated that the Area Committee wished it to be noted :-

- That Bishop Wulstan Catholic School enjoys unanimous support from the parent body, Catholic and wider Rugby community, as demonstrated by the responses to the LEA's consultation;
- The hard work and commitment of the Head, Brendan Higgins, the staff, parents, students and governors, particularly during this difficult period;
- The School's recently acquired Business and Enterprise Specialist Status and the new state-of-the-art sports facilities which, the School anticipates, will contribute to an increase in pupil numbers and also yield improvements in student achievement;

 - i. that the proposal to close Bishop Wulstan Catholic School be withdrawn;
- (ii) that the alternative proposals from the four Catholic schools of Rugby and the Archdiocese of Birmingham as detailed in Section 5 of the Director's report be pursued with a serious and rapid evaluation of the 3-16 options and that the LEA give active support to the evaluation of these options.

After all Members of the Committee had spoken in favour of the motion, it was put to a vote and carried unanimously.
