Capital Programme for Transport 2007-8

Report of the Strategic Director for Environment and Economy

Recommendation

That Members:

- 1. Support the Capital Programme for Integrated Transport for Warwick Area given in Table 1.
- 2. Support the schemes identified in Table 3 for the delegated budget.
- 3. Agree that schemes listed in Table 4 be removed from the list of requests.

1. Introduction

- 1.1 A seminar for Warwick Area Committee Members was held on 23rd January 2007. At the seminar a draft 2007-8 programme of integrated transport schemes was discussed. The purpose of this report is to enable Warwick Area Committee to formally support the proposed programme for Warwick Area.
- 1.2 The full programme for all five Area Committees will be reported to Cabinet on 10th May 2007.

2. Capital Programme for Warwick Area

2.1 The draft Capital Programme for Integrated Transport is given in Table 1. It is recommended that Area Committee resolves to support this programme. A costed programme of schemes will then be developed within the resources available, and reported to Cabinet in May.



Table 1 – Programme of Integrated Transport Projects for Warwick Area 2007-8

Traffic Management / Congestion Management

Warwick Town Centre Traffic Management Schemes – Bus Interchange; Car Park Management Signing; Pedestrian Crossing, West Street; Hampton Street/Friar Street 20mph (preliminary design trials).

Variable Message Signing for Car Parking in Learnington Spa.

CCTV for Congestion Management – Warwick and Leamington - Preliminary design 2007-8. Implementation if funds allow.

Decriminalisation of Parking in Warwick Area.

Village Speed Limit Reviews

C16 Burton Green.

Public Transport

Warwickshire Quality Rail Partnership Hatton Station Car Park Extension - continuation of preliminary design and investigation of land issues. *A favourable response has recently been received from the land owner and we are optimistic that it may now be possible to deliver the scheme in 2007-8.*

Warwickshire Quality Rail Partnership Lapworth Station Car Park Extension - continuation of preliminary design and investigation of land issues.

Bus Information Points - Warwick Bus Interchange (in conjunction with Warwick bus interchange).

Parish Council Bus Shelter Initiative - funding for parish council bus shelters requests.

Safer Routes To Schools

Lillington Road Cycle Route (North Leamington School) – new scheme based on revised design.

Aylesford to Woodloes Cycle Route Phase 2 (Saltisford Common).

Aylesford School to Woodloes Park Cycle Route Phase 3 (Cape Rd to Woodloes Park) - bridge improvement and negotiations regarding land on Lock Lane.

Bishops Tachbrook to Warwick Gates cycle route.

Burton Green School - pedestrian refuge/splitter island.

Whitnash Primary School – footpath link.

Campion School - cycle route to Radford Semele (investigation).

Crossing Facilities

Dropped Kerb Programme for Warwick Area (£20,000).

Tachbrook Road/Queensway junction upgrade.

Binswood Street, near Trinity Street, Leamington – puffin crossing. Consultation 2007-8. Implementation planned for 2008-9. Scheme will be brought forward into 2007-8 if funds allow.

Foot/Cycleways

Tachbrook Road, Leamington Spa, shared use cycle/footway between Queensway and High Street – consultation planned for Spring 2007, implementation October 2007.

A429 Coventry Road shared use cycle/footway between Primrose Hill Roundabout and A46 Roundabout.

Barford to Bridge over M40 cycleway (to link with Stratford cycle route to Warwick). Shires Retail Park cycle/pedestrian access improvements – preliminary design 2007-8, implementation late 2007-8/early 2008-9.

Contribution to Kenilworth - Berkswell Greenway (Countryside Recreation scheme).



Casualty Reduction

A425 Myton Road - 30mph speed limit, pedestrian refuges and interactive signs.

A452 Europa Way - feasibility study/traffic modelling - continue with work started in 2006-7.

Queensway, Leamington - speed cushions.

B4113/B4115 Finham.

3. Countywide Projects

3.1 In addition to the programme listed in Table 1 there are a number of countywide allocations which Cabinet will be asked to approve. These are listed in Table 2, below. A programme of schemes for these allocations will be developed during the year with appropriate consultation with local Members and Area Committees.

Table 2 – Countywide Allocations 2007-8

Casualty Reduction Schemes - identification of new 'cluster' sites and implementation of minor casualty reduction schemes

Public Transport - minor schemes aimed at improving the quality and attractiveness of public transport (e.g. shelters, signing etc.)

Congestion Management – feasibility of variable message information (free text) signs, giving details of forthcoming events, delays, roadworks etc

Enhancements to existing pedestrian crossing facilities for the benefit of disabled persons

Cycling Projects Fund – parking, signage etc

4. Delegated Budget for Warwick Area

- 4.1 At Cabinet on 11th January 2007 it was agreed that a sum of £40,000 would be delegated to each Area Committee to allocate to transport projects according to local priorities. A list of possible schemes for such funding was presented and discussed at the seminar on 23rd January.
- 4.2 Members selected three schemes for implementation in 2007-8 and one scheme to be carried forward to next year for re-consideration, see Table 3. It was agreed that any remaining funding should be used for posts for temporary Vehicle Activated Speed signs and the installation of bollards to prevent vehicles parking inappropriately.




