# **Report of the Area Community Learning Partnership**

#### **Recommendations:**

- (1) That the progress made in the development of the Community Learning Strategy and the multi-agency Community Learning Plan for Warwick District is noted.
- (2) That the detailed progress report against 2006/07 actions be endorsed.
- (3) That the Area Committee gives its comments on the draft outline plan and actions for 2007/08.
- (4) That a finalised Area Community Learning Plan for 2007/08 is made available to the Area Committee for information in the summer.

### 1. Background

- 1.1 The development of the Community Learning Strategy and multi-agency Community Learning Plans enable the Local Authority and all partner organisations:
  - To engage in new ways with the local community, so that learners, parents and carers, and our partners are all working together to help learners of all ages to achieve their potential.
  - To enhance communication and understanding across the range of learning provision.
  - To ensure that increasingly complex arrangements for learning:
    - Are planned more coherently to avoid needless duplication
    - Have agencies working together not in competition with each other
    - Seek to respond to the differing needs of local communities
    - o Are subject to local democratic scrutiny.



- 1.2 The Area Community Learning Partnership (ACLP), which has met regularly since April 2003, is co-ordinated and serviced by the Schools and Communities Team of the Children, Young People and Families Directorate and is the vehicle through which the Area Community Learning Plan has been developed.
- 1.3 The ACLP is currently the 'Lifelong Learning Theme Group' for the Warwick Local Strategic Partnership.
- 1.4 Progress against the 2006/07 action plan was monitored by the Partnership on a regular basis and all partner agencies contributed to the process. A full progress report for 2006/07 is attached at **Appendix A**.

#### 2. The Area Community Learning Plan 2005/08

- 2.1 Progress made against the Community Learning Plan for 2006/07 has been encouraging and has given partner agencies a firm basis to build upon when considering future working.
- 2.2 The ACLP is a key vehicle for supporting the extended services agenda within localities. It is also key to encouraging a multi-agency response to meeting the objectives of the Local Area Agreement allowing flexibility and providing local solutions.
- 2.3 Attached as **Appendix B**, Members will find a draft outline plan for 2007/08. This document includes a brief summary of progress to date along with a partnership activity action plan for 2007/08.
- 2.4 In recognition of the wealth of activity taking place within the District in support of the ACLP priorities, a directory of activity is included at the back of the plan. This information will be updated annually and will be used to encourage dialogue and joint working to facilitate and support the priorities of the ACLP.
- 2.5 The ACLP welcomes the comments of Area Committee and will look to finalise the plan in late May/early June. A copy of the finalised plan will be shared with Members in the summer.

#### WHAT IS THE AREA COMMUNITY LEARNING PARTNERSHIP?

The Area Community Learning Partnership (ACLP) is the Education and Lifelong Learning "Theme Group" of the Local Strategic Partnership for Warwick District. It consists of representatives of local government, health, education bodies, business, and voluntary and community organisations. We operate by bringing the various agencies together to learn from and influence each other in the interests of the people of Warwick District. This plan describes their commitment to cooperate in order to improve learning opportunities for people in the area.

## **OUR LONGER TERM PRIORITIES AND FOCUS**

The ACLP believes that Warwick District should be "a total learning community" where everyone, regardless of age or life circumstances, is enthusiastically engaged in learning. This will bring benefits to individuals, families, communities, the economy and the environment. It will also continue to work to avoid duplication both within the statutory and voluntary and community sectors.

In order to achieve this we will need to make sure that:

- people can learn in places convenient to them whether this is at home, in a family setting, at work, in places dedicated to learning like libraries, schools and colleges, in a local community centre or elsewhere
- the value of learning is understood by those making decisions about resources to ensure the best possible learning resources are available to learners in the district
- full use is made of technology including computers to make learning available to everyone.
- barriers to learning have been reduced so that everyone has the chance to satisfy their learning needs.
- all organisations that provide learning work closely together to ensure that the needs of learners are put before the needs of their organisations, so that the best use is made of available resources and learners can freely and easily move from one organisation to another



#### **OUR VISION FOR 2005/08**

The Area Community Learning Partnership has identified the following issues as priorities for collaborative working through to 2008

- To develop common expectations and standards for adult learners across all providers of community based Information, Advice and Guidance, Essential Skills and Basic Information and Communication Technologies (ICT) provision.
- To develop consumer education /access to legal rights / financial literacy.
- To increase the availability of learning opportunities for under-represented groups and communities.
- To enhance the community-learning role of schools, libraries and community buildings and to promote the co-location of services.
- To support the development of flexible learning opportunities to meet individual and employer need.
- To improve access to youth provision and informal learning opportunities for young people especially in the priority communities and groups.
- Support for parents, carers and families generally including the development of Sure Start, Children's Centres and Neighbourhood Nurseries.

#### WHAT HAVE WE DONE SO FAR?

A major focus for the Area Community Learning Partnership since the beginning of 2004 has been to develop a network of organisations across Warwick District who are committed to supporting learning for adults (16+) and families. Successful funding bids were submitted to the Learning and Skills Council for Coventry and Warwickshire and the Government Office for the West Midlands to enable us to appoint a dedicated Development Worker to take this initiative forward.

The success of the project has enabled us to secure additional funding and subsequently expand the staffing. We are now looking to ensure the longterm sustainability of the network and to promote the work of CHOICES in the wider area. The CHOICES Network is to become a Community Interest Company with all relevant papers being submitted for consideration in early February.



We piloted a home learning scheme within Warwick. The Help a Mate project encourages people to take on home learning around a number of issues but to help people become active members of their community. A number of people took part in the programme and some have now gone on to take part in more learning opportunities.

Work has also taken place to build collaborative partnerships between a range of learning providers for young people aged 14 – 19 years.

Partner agencies have continued to work throughout the District to ensure that people have opportunities to learn close to where they work or live. Learning Opportunities are provided throughout the week and at different times of day.

The ACLP has been extremely supportive of the development of extended services and children's centres within the borough. Both will see access to services for children and families enhanced and represent a joined up approach to providing what the neighbourhood needs in a location which is convenient to them.

#### OUR FOCUS FOR 2007/08

Below you will find an action plan of how the ACLP aims to address the priorities identified in this document. At the end of twelve months a progress report will be produced along with an updated action plan giving the focus for the following twelve-month period. The Warwick Local Strategic Partnership and individual partner agencies will consider reports on progress.

At the back of this plan you will find a list of current members of the ACLP along with their contact details and a directory of existing partnership working within the District, which actively supports the priorities of the ACLP.
