4. Warwick Bus Station – Outcome of Public Consultation

Report of the Strategic Director for Environment and Economy.



A public consultation exercise on the final layout of the proposed Warwick Bus Station has been conducted. Warwick Area Committee is asked to endorse the layout of the Warwick Bus Station and also to support the progression of the scheme. Area Committee is also asked to approve the advertising of Traffic Regulation Orders as required in relation to the scheme.

Recommendation

6. Speed Limit Review of A and B Roads

Report of the Strategic Director for Environment and Economy.

The technical review of existing speed limits on A and B roads is progressing. This report recommends a procedure whereby Area Committees can take into account any community concerns when prioritising schemes to alter any speed limits.

Recommendation

That the proposed procedures for taking into account community concerns in carrying out the review of A and B road speed limits be approved.

7. Highway Maintenance and Safety Budget 2008-09 - Outline Capital Allocations

Report of the Strategic Director for Environment and Economy.

At its meeting of 6 February 2007 the County Council approved a £2 million 2008-9 capital allocation to Highway Maintenance and Safety; £400,000 for each of the County's five areas. The funding is to be allocated to local schemes in consultation with Area Committees. This report makes proposals for outline capital allocations within the £400,000 for Warwick area. When Area Committee has agreed the outline allocations a programme of capital schemes will be prepared for discussion at the Transport Seminars in early 2008.

Recommendation

That:-

(1) The outline capital allocations for the Warwick Highway Maintenance and Safety Budget 2008-9 given in Table 1 be approved.



(2) A detailed programme of capital projects based on the allocations in Table 1 be prepared for discussion at the seminar early in 2008.

Kenilworth is the first area to be reviewed and this report sets out the findings in respect of Warwickshire County Council's properties and details the results of our discussions with partners.
