Proposed Changes to Parking Fees and Charges across Warwick District

Report of the Interim Strategic Director for Environment and Economy

Recommendation

That Warwick Area Committee:-

- Endorses Warwick District Council's proposed changes to off-street car parking across Warwick District.
- 2. Approves an increase of the on-street parking charge in Learnington Spa Town Centre from £1.80 to £2.00 for a two hour stay, in line with Warwick District Council's proposed off street car park charging strategy.

1. Introduction

- 1.1 Warwick District Council is proposing a number of changes to parking services within Warwick District. This includes small increases in charges for some parking durations.
- 1.2 Warwickshire County Council has been invited, as consultee, to respond to these proposals. The purpose of this report is to seek Members' views of the proposals.
- 1.3 This report considers these proposals in relation to the County Council's Parking Strategy contained within Warwickshire's Local Transport Plan (LTP) 2006-2011.

2. Background

2.1 The current LTP Parking Strategy is intended to help maintain and enhance the economic vitality of town centres by reducing congestion, while ensuring that enough good quality parking is available to support the continuing viability of retail and leisure facilities.



- 2.2 The parking policies included in the second LTP seek to:-
 - (i) Make sufficient short stay parking available at a cost and convenience that will enable every town to be competitive and promote economic vitality.
 - (ii) Reduce the impact of the car on town centres.
 - (ii) Control the amount and/or price/or location of long stay parking.
 - (iii) Reduce the proportion of long stay parking, possibly replacing long stay with short stay parking.

3. Warwick District Council Proposals

- 3.1 There are a number of proposed changes to parking services in Warwick District. The changes include:-
 - (i) Increasing the charges in long stay car parks in both Leamington (Rosefield Street and Adelaide Road) and Warwick (St Nicholas Park, West Rock, Barrack Street and St Mary's Land area 2 and 4). The proposed changes to charges in long stay Leamington car parks include an increase of 10p for stays of up to one and two hours, an increase of 20p for stays of up to three hours, an increase of 40p for stays up to six hours and a 30p increase for stays over six hours.

In Warwick long stay car parks, there are no proposed increases for stays of up to half an hour (St Nicholas park only). Proposed increases in charges include a 10p increase for stays of up to one and two hours and an increase of 30p for stays up to three, four and six hours. Charges for stays over six hours will be increased by 50p

(ii) Increasing the charges in limited stay car parks by 20p for two hours in Learnington. This increase has been targeted at the most well used car parks in Learnington, namely Chandos Street, Bedford Street and Covent Garden surface car parks.

This proposed increase means that parking in these car parks will be more expensive than the existing on street parking charges. Subject to approval from Area Committee, the County Council propose to increase on street parking charges from £1.80 to £2.00 for a two hour stay in Learnington town centre in line with the District Council's proposed increases.

There are no increases proposed in the town centre limited stay car parks in Warwick. Increases of 30p for stays of 2-3 hours 3-4 hours are proposed for St Mary's land, area 3.

(iii) Increasing the charges in the pay on foot car parks (Covent Garden and St Peters) in Learnington by 10p for stays of up to two and four hours, by 20p for stays of up to three and six hours, by 30p for stays over fifteen



hours and by 40p for stays between six and fifteen hours. There is no proposed increase for stays of up to one hour.

- (iv) Increasing the charges in Learnington Old Town car parks, namely Bath Place, Packington Street and Court Street, by 10p for stays of up to one, two and three hours, an increase of 20p for stays of up to four hours and 30p for stays for over four hours.
- (v) Increasing the charges in Warwick short stay car parks, namely Linen Street and Priory Road by 10p for stays up to one and two hours, by 20p for stays up to three hours, 30p for stays of up to four hours, 40p for stays up to six hours and 50p for stays over six hours.
- (vi) In Kenilworth, namely Abbey End and Square West car parks, it is proposed that charges for stays up to half an hour, one and two hours remain unchanged. It is proposed that stays of up to three and four hours be increased by 10p and stays over six hours increase by 30p. It is proposed that these charges stay in place until six months after the opening of the Waitrose store (due to open in August 2008), after which charges should be increased to the level in place in Warwick for long stay parking and changes in charges for stays up to two hours will be introduced. There are currently no evening or Sunday charges in operation in Kenilworth. Warwick District Council will review this arrangement after Waitrose has opened. Warwick District Council are in discussions with Waitrose to try and establish how they plan to manage their car park which will replace the old Talisman Square car park.
- (vii) It is proposed that the charge levied for releasing a motor vehicle from a locked car park out of hours will increase from £45 to £50.
- (viii) The Special Event Charge is proposed to be increased from £4 to £5 per vehicle. This proposed increase reflects the increasing costs associated with providing additional security and lighting at locations such as Myton Fields.
- (ix) It is proposed that the charge for altering a season ticket be increased from £5 to £6, reflecting increased administration costs.
- (x) The cost of the evening car park season ticket will be held at the current level.
- 3.2 For details of all proposed increases in charging refer to **Appendix A**.

4. Comments

- 4.1 The proposals by Warwick District Council are broadly consistent with the aims and objectives of the Local Transport Plan 2006-2011. Points to note include:-
 - (i) Increase in parking charges. These proposed increases in the majority of time bands, with the greatest increases for longer durations, in short stay car parks will serve to increase the price differential between time bands



and discourage people from parking for long periods of time. This may help deter long stay commuter car parking, helping to maintain the vitality and viability of the town centres, in accordance with LTP parking policies.

- (ii) The provision of short stay car/limited stay car parks within the town centres will help to maintain the economic vitality and viability of the Town centres in the District, helping to reduce the impact of the car due to reduced congestion as a result of less circulating traffic seeking parking spaces, in accordance with LTP parking policies.
- (iii) The continued provision of season tickets will help attract commuter parking to particular car parks which are located on the edge of town, particularly in Warwick. This will help to prevent commuters taking up space in short stay/limited stay car parks.
- 4.2 It is recommended that Warwick Area Committee endorse the proposed changes to off-street car parking across Warwick District. Further, it is recommended that Warwick Area Committee approves an increase of the on-street parking charges for a two hour stay in Leamington town centre.
