5. Barford - Sherbourne Cycleway

Report of the Interim Strategic Director for Environment and Economy.

It is proposed to convert the existing footway along the A429 between Barford and Sherbourne to a shared use footway/cycleway. In conjunction with existing cycle facilities, the scheme will complete a link from Barford village to Warwick and improve a section of the National Cycle Network route 41 between Warwick and Stratford.

Recommendation

That Area Committee approve the conversion of the eastern footway on the A429 between Barford and Sherbourne, as highlighted on the Plan in Appendix A, to a shared use footway/cycleway.

6. Warwick Town Centre Traffic Management Review - Funding Arrangements

Report of the Interim Strategic Director for Environment and Economy.



At its meeting on 22 January 2008, this Committee discussed the progress being made by the Warwick Town Centre Traffic Management Forum on developing 'street by street' proposals. This Committee asked that a report be submitted on the funding arrangements to achieve both the rapid implementation of the detailed design stage, and for the future construction stage. In addition, this report sets out the proposed approach to achieving Committee's resolutions on the implementation of the detailed design stage and the establishment of a joint study group.

Recommendation

That Committee:-

- (1) Notes the information on the Section 106 agreements relating to the South West Warwick development.
- (2) Allocates £40,000 from its delegated budget to pump-prime the costs associated with its previous resolution that the rapid implementation of the detailed design stage takes place.
- (3) Approves the proposal for the establishment of a Programme Board to oversee the development of the Forum's proposals, and of a Joint Study Group to examine the possibility of road user charging or gating using traffic signals.
