### Report of the Planning and Performance Working Group

#### Recommendations

That the Warwickshire Police and Crime Panel:

- (1) Considers the minutes of the Planning and Performance Working Group meeting, held on 12 August 2016 (appended to this report).
- (2) Considers a presentation from the PCC funded cyber advisors at their 1 December 2016 meeting on the current state of cybercrime in Warwickshire

#### 1.0 Recent Activity of the Working Group

##### 1.1 Police and Crime Plan – Delivery Plan Performance

The Working Group reviewed the latest updated delivery plan and made the following observations/suggestions:

- The group agreed to review smaller sections of the Delivery Plan throughout the year, starting with alcohol and drugs, and protecting vulnerable people at their next meeting.
- The group requested an answer regarding whether the PCC receives performance data for the National Probation Service Programme and/or the Community Rehabilitation Company. They asked to view any associated reports that are available.
- The group requested that the value for money / sustainability report on Operation Devonport be brought to the working group, when it is available.

##### 1.2 Police Force Performance Summary

The Working Group reviewed the performance summary and made the following observations/suggestions:

- Once the force has completed their Intel problem profile of CSE, and the Commissioner has had the opportunity to hold the force to account on it; if

the Chief Constable agrees, the working group requests that it be shared with them.

- The group requested that the Commissioner considers reviewing which force areas that he compares Warwickshire with, given that the Most Similar Group (MSG) forces are not bordered by metropolitan areas and do not have the same level of cross-border crime.
- The group requested to view the Chief Constables responses to a number of questions posed by the PCC, and the 'Complexities of Outcome Data' report. These documents were circulated to group members on 12 August 2016.
- The group welcomed the valuable input provided by Chief Superintendent Debbie Tedds, and requested that her involvement with the group continues.

The next meeting of the Working Group is scheduled for Wednesday 2 November, at 3.00 p.m.
