 - Declare the interest if s/he has not already registered it
 - Not participate in any discussion or vote
 - Must leave the meeting room until the matter has been dealt with (Standing Order 43).
 - Give written notice of any unregistered interest to the Monitoring Officer within 28 days of the meeting

Non-pecuniary interests must still be declared in accordance with the Code of Conduct. These should be declared at the commencement of the meeting.
